**COUNCILMAN LEWIS** – I make a motion that we accept the Auditor's Report.

**COUNCIL PRESIDENT ISTNICK** – Seconded by Councilwoman Starrett. Roll call.

9 yes to accept the Auditor's Report

**COUNCIL PRESIDENT ISTNICK** – Mayor, would you like to tell Council what's going on in Massillon?

MAYOR CATAZARO-PERRY – I would love to, thank you, Madam President. This is the Council update for May 17, 2021. Duncan Plaza ribbon ceremony is scheduled for May 27, 2021 at 11:00 a.m. You should have all received your invitation. Today is the last day to file your income tax. Our downtown landscaping is in process. Soon they'll be placing the flower pots, trash receptacles and benches and we're just waiting for the flower pots to take hold and then they'll be bringing them out. The Memorial Day parade is May 31st; at 9:30 a.m. it will kick off and following the parade at Duncan Plaza and Veteran's Memorial Park there will be a ceremony. The paving is starting on the catch basins for our Contract 1 and they will be moving to paving following the catch basin repair and replacement. They also started Erie St. S. catch basins. Contract 2 for our street cleaning, what's in front of you tonight and we appreciate you passing that as an emergency measure so that we can get out bid, thank you, Council. Just an update on the Health Dept.; the verbage, as I reported last time, was changed to 50,000 or less. The Health Dept. must do a feasibility study on efficiency and if we are merging with the County. We made significant roads with our legislators at the State level and we continue to communicate with them because having our own Health Dept. in the City of Massillon is vital for our residents. And that's all I have for you this evening. Thank you.

**COUNCILMAN LEWIS** – Madam President.

**COUNCIL PRESIDENT ISTNICK** – Yes.

<u>COUNCILMAN LEWIS</u> – My first request is that we have more discussion at our next Work Session. If they could present to Council more information. My second statement that I would like to make tonight is in regards to Ord. No. 93 – 2021 that we gave a first reading to. The opportunity to vote has already passed. Mr. Lombardi.

**COUNCILMAN LOMBARDI** – I agree.

**COUNCIL PRESIDENT ISTNICK** – Councilman Lewis.

**COUNCILMAN LEWIS** – I make a motion to reopen discussion for Ord. No. 93 – 2021.

**COUNCIL PRESIDENT ISTNICK** – Seconded by Councilman Gregg. Roll call.

9 yes to reopen discussion on Ord. No. 93 – 2021

**COUNCIL PRESIDENT ISTNICK** – Thank you, Diane. Councilman Lewis.

<u>COUNCILMAN LEWIS</u> – Yes, there are members on Council that have questions. Councilwoman Creamer.

<u>COUNCILWOMAN CREAMER</u> – Thank you, Mr. Lewis. At the Work Session, I had questions as are we going to keep going into that fund? I questioned information from the Auditor in reference to this TIF about this project.

**COUNCIL PRESIDENT ISTNICK** – Anyone else?

**COUNCILMAN LEWIS** – I need to ask the Administration if that question is understood?

<u>MAYOR CATAZATO-PERRY</u> – I'm sorry, Mr. Lewis. We can't understand; it's very muffled on our end.

<u>COUNCILMAN LEWIS</u> – The question is, is this the first or second time that the Administration has used these funds of the Wales Rd. project?

<u>MAYOR CATAZARO-PERRY</u> – Actually, it's the second one that you have received, but the initial amount was a little less than a million dollars. So, this is much less than we anticipated. Several hundred thousand less than we anticipated.

<u>COUNCILMAN LEWIS</u> – So now, Mayor, you're saying that you came to us before for approval of a half million dollars and now you need \$450,000?

<u>MAYOR CATAZARO-PERRY</u> – Correct. I was only a portion; we only came to you for a portion of it. And this is the other portion. This is much less than we anticipated. We thought use about \$900,000 and we're not going to use that amount.

**COUNCILMAN LEWIS** – So, you didn't have to use any money geared to us.

**MAYOR CATAZARO-PERRY** – I can tell you that the bid came in lower and so, that's why the amount is smaller.

**COUNCILMAN LEWIS** – How much was the total?

<u>MAYOR CATAZARO-PERRY</u> – The total is \$676,000 and we were thinking that it was going to be closer to a million like \$960,000. But the total amount is \$676,000. Actually, Jason just sent me a message; a million-three is what we thought it was going to be. So, it's significantly lower. I think this is really good, and again, this is ODOT and this is our share.

<u>COUNCILMAN LEWIS</u> – The question is, how much has the City spent on the project from the Marketplace TIF?

**DAVE MALEY** – It's in the \$425,000 market.

**COUNCILMAN LEWIS** – If I'm understanding you correctly you have used \$251,000 so far?

**DAVE MALEY** – Mr. Lewis.

**COUNCILMAN LEWIS** – Yes.

<u>DAVE MALEY</u> – I'm on the phone with Jason Popiel and for some reason, he can't be heard, but he told me that \$575,334 is the total amount that's going to be coming out of the Marketplace TIF out of the \$676,000.

<u>COUNCILMAN LEWIS</u> – I'm sorry, we tried but we are not able to clearly understand. I'm going to stay with my first reading and then if the Administration can somehow communicate with Council, I suggest a Special Meeting next Monday. With that said, first reading.

**COUNCIL PRESIDENT ISTNICK** - Ord. No. 93 - 2021 has received first reading.
