We have in attendance the following City officials: Safety Service Director, Barb Sylvester, Chief Deputy Auditor, Stefanie Myers, Chief Counsel, Bill Bartos and Economic Development Director, Dave Maley. Under #5 on the agenda is where the public can speak on any topic that appears on tonight's agenda and under #17 is where the public can speak on any topic that does NOT appear on tonight's agenda. I'd like to remind everyone keep your mics off until you're ready to speak and please, mute your cell phones. Thank you.

COUNCIL PRESIDENT ISTNICK – Roll call.

COUNCIL PRESIDENT ISTNICK – Thank you. Councilman Lewis.

COUNCILMAN LEWIS – I make a motion that we excuse Councilman Thieret.

COUNCIL PRESIDENT ISTNICK – Seconded by Councilman Herncane. Roll call.

8 yes to excuse Councilman Thieret

<u>COUNCIL PRESIDENT ISTNICK</u> – Thank you, Madam Clerk. Councilman Thieret has been excused.

COUNCIL PRESIDENT ISTNICK – Thank you, Councilwoman Creamer. Madam Clerk are the minutes of the previous meeting transcribed and open for public viewing?

COUNCIL CLERK ROLLAND – Yes they are. All minutes are posted.

COUNCIL PRESIDENT ISTNICK – Are there any additions or corrections to be made?

COUNCIL CLERK ROLLAND – No, there are not.

COUNCIL PRESIDENT ISTNICK – Then the minutes stand approved as written.

5. REMARKS OF DELEGATIONS AND CITIZENS TO MATTERS ON THE AGENDA

YVONNE DANIELS – 222 – 21st St. S.E., Massillon, Ohio. I'm here because I had rented a park for the Memorial Holiday. On the 24th I rented South Sippo and they told that you can't get in there until that day. But, I go down there that morning, 10:00 a.m. and the bridges are closed. You can't even get over to the pavilion; they're blocked and they tell you to stay off the bridge. So, I made my way to the Rec Center, so, there's nothing there that says that you can't use the pavilion, but there's no way to get to it. I had people in wheel chairs. So, I asked her if she could find something else for me. So, she gave me Shriver Park. But the Shriver Park, it's all messed up, trash cans full. I had to clean it up before I could do anything. Then, so I did that; went back home and came back and the people had started coming, the bathrooms are closed. Had signs on it saying that they were closed until further notice.

<u>COUNCIL PRESIDENT ISTNICK</u> – Yvonne, I'm going to stop you for one minute, okay. This part of the agenda is for something that's on the agenda tonight and this is not. But since you started, I'm going to let you continue.

YVONNE DANIELS – Okay. The lady at the Rec Center she says, "Oh, there's nothing about the parks. They were available, that's all. She's going to tell her supervisor about it and she'll call you or whoever, but I never heard anything from anybody. I called back to that Rec Center before they closed that day. I told her what was going on so that somebody could come and help clean it. But, that didn't happen because there wasn't anybody. But I'm just saying, I think they owe me a refund.

<u>COUNCIL PRESIDENT ISTNICK</u> – We will get someone from the Parks and Rec. Dept. to give you a call.

YVONNE DANIELS – Okay.

<u>COUNCIL PRESIDENT ISTNICK</u> – If you could leave your name and address and phone number and we will have someone call you back.

YVONNE DANIELS – Alright. Thank you.

COUNCIL PRESIDENT ISTNICK – Thank you, Yvonne.

YVONNE DANIELS – You don't have anything on the zoning tonight, do you?

COUNCIL PRESIDENT ISTNICK – On zoning?

YVONNE DANIELS – Yes.

COUNCIL PRESIDENT ISTNICK – Zoning of what, Yvonne?

YVONNE DANIELS – I had called the Zoning Commission back, probably about a year ago when the COVID was really bad and he said he'd look into it. I asked him if he could, what it is is that the people that live directly behind me, they have all of their spouting coming in my yard.

COUNCIL PRESIDENT ISTNICK – What's the address?

YVONNE DANIELS – I think, I'm not sure, but I think it's 228 – 22nd St., I'm not sure. But, if that guy, what he told me, he had to give them time to do stuff. If he really looked into it, he should have the address.

COUNCIL PRESIDENT ISTNICK – Okay. I don't believe that that is on the agenda tonight.

YVONNE DANIELS – Okay. I don't want to come back, but I'm going to call somebody down there. Alright, thank you.

COUNCIL PRESIDENT ISTNICK – Anyone else?

COUNCIL PRESIDENT ISTNICK – I had spoken about getting the PA system in here fixed. Mr. DeWalt was going to come in and give us a presentation on his two proposals. COUNCILMAN LEWIS – And what is the purpose of this one and what's the economic growth that it will bring?

COUNCILMAN HERNCANE – You want to ask Mr. Maley up?

COUNCILMAN LEWIS – Yes.

COUNCIL PRESIDENT ISTNICK – Mr. Maley if you'd come forward. Thank you, Mr. Maley.

<u>DAVE MALEY</u> – Mr. Lewis, this is for an expansion that Ms. Boyd is doing. We do allow for expansions out of the grants. She's looking to hire 10 full-time people with the expansion. Basically looking at, I think she's bringing in 6 – 7 booth rentals for stylist. Four for tanning beds, etc. Revenue anticipated is about \$375,000; payroll of about over \$300,000. I know that she is in the downtown plaza. Two of the spots to either north or south, I'm not sure, next to her became vacant and she's actually taking those spots over to expand her business.

<u>COUNCIL PRESIDENT ISTNICK</u> – Any other questions while Mr. Maley is up here? Thank you, Mr. Maley. Councilman Herncane.
