We have in attendance the following City officials: Mayor, Kathy Catazaro-Perry (late), Safety Service Director, Barb Sylvester, Chief Deputy Auditor, Stefanie Myers, Law Director, Justin Richard, Chief Counsel, Bill Bartos, Economic Development Director, Dave Maley, Income Tax/Budget Director, Lori Kotagides-Boron and Code Enforcement Officer, Jimmy Johnson. Under #5 on the agenda is where the public can speak on any topic that appears on tonight's agenda and under #17 is where the public can speak on any topic that does NOT appear on tonight's agenda. <u>COUNCIL PRESIDENT ISTNICK</u> – Thank you, Councilman Lewis. Madam Clerk are the minutes of the previous meeting transcribed and open for public viewing?

COUNCIL CLERK ROLLAND – Yes they are.

COUNCIL PRESIDENT ISTNICK – Are there any additions or corrections to be made?

COUNCIL CLERK ROLLAND – No, there are not.

COUNCIL PRESIDENT ISTNICK – Then the minutes stand approved as written.

5. REMARKS OF DELEGATIONS AND CITIZENS TO MATTERS ON THE AGENDA

JASON WELSCH – The topic I'd like to discuss is I'm building a house on a vacant lot.

COUNCIL PRESIDENT ISTNICK – And your address.

JASON WELSCH – 1809 Lincoln Way W., Massillon, OH. I have a double lot. It's Parcel No. 603098. I'm trying to build a house down there and a few of the neighbors don't think that I should build because they think it's going to be out of place or it's not going to look right or it's going to cause them to get too much water because it's on a hill. With the house being down there, you're going to have storm drains. So, it's going to take away water if anything. But, also, if you look at it, I know the codes were put there for a reason, but, that reason being so houses aren't too close together and both my neighbors on each side of my house, one's got a double lot and the other has a triple lot and they got single houses. Which both houses are at least 40 to 50 feet from their property line. So, I don't see no problem with a house being put there. Just down the street we've got single lots, house by house by house. They're just smack beside each other. I don't see no problem with me having a new house put in there. And then, neighbors across the street don't think I should be too close to the street, but, their houses are only 15 to 20 feet off the property line. So, I don't see how it's going to be out of place if I did get the variance of 20 feet away from the street. It don't make sense. That's just the way I see it.

<u>COUNCIL PRESIDENT ISTNICK</u> – Okay. This isn't a question or answer session. You've said your piece and I appreciate that.

<u>JASON WELSCH</u> – Also, I complied with all the stuff the neighbors wanted me to do to get the lot presentable for them. They wanted the lot cleaned up. I've been building a shed and a pool and I know it's been a nuisance to everybody; I had a bobcat back there, I've been dealing with nail guns and roofing guns and it's been waking people up and it's just a nuisance, it is. I know it's made people mad, but, what can you do? Now I'm wanting to do a house and I think that's the main complaint. They're tired of hearing the noises.

<u>COUNCIL PRESIDENT ISTNICK</u> – Thank you, Jason. Is there anyone else from the audience that would like to speak on any topic that does appear on tonight's agenda?

<u>JERRY VESS</u> – Good evening. I live at 1805 Woodruff Ave. N.W. My property is directly across the street from the lot in question on these variances. He wants to build his house on a 50-foot lot which used to be okay with the City because the City plotted all these 50-foot wide lots and we have several houses now on that street that are on 50-foot lots. I've been told by Mr. Welsch that if he doesn't get to build this house, he's going to build a garage there which you can do by combining the two lots together. My personal thing is that I think it's much better for a house than a garage. I have a picture here of the house he wants to build and I think it'll be a decent fit in the neighborhood. So, I really don't see any reason to disapprove the variances.

COUNCIL PRESIDENT ISTNICK – Please note Mr. Vess, that we all have a copy of that picture.

JERRY VESS - That's all I got to say.

<u>COUNCIL PRESIDENT ISTNICK</u> – Thank you. Anyone else from the community that would like to address Council?

<u>COUNCIL CLERK ROLLAND</u> – We received notice to accept or reject annexation by ordinance or resolution from the Stark County Commissioners. It's an ordinance that we passed by in November 2021. Everyone should have received a copy of this and it's just stating that we need to proceed with a request for legislation to introduce a resolution to either accept or reject the annexation. So, I will draw up a request for legislation to be presented at the Work Session for Monday.

7. INTRODUCTION OF ORDINANCES AND RESOLUTIONS

COUNCIL PRESIDENT ISTNICK – Ord. No. 110 – 2022.

<u>ORDINANCE NO. 110 – 2022</u>

BY: STREETS, HIGHWAYS, TRAFFIC AND SAFETY COMMITTEE

AN ORDINANCE authorizing the Director of Public Service and Safety of the City of Massillon, Ohio, to enter into an agreement for Stark County's Co-Operative Purchasing Program for the purchase of salt for City Streets for the 2022-2023 season and possible extension for 2023-2024 season, and declaring an emergency.

COUNCIL PRESIDENT ISTNICK – Councilman Thieret.

<u>COUNCILMAN THIERET</u> – Thank you, Madam President. As we discussed at the last Work Session, this is an agreement that we've been using for a while now for purchasing our road salt through the Stark County Co-Op Purchasing Program. There was a slight increase as noted by Director Sylvester, but again, if there's any questions I know the Director is here.

COUNCIL PRESIDENT ISTNICK – Councilwoman Creamer.

<u>COUNCILWOMAN CREAMER</u> – Do we know a dollar figure of the impact of the price increase?

COUNCIL PRESIDENT ISTNICK – Mrs. Sylvester if you could come forward; thank you.

BARB SYLVESTER – Good evening. Yes, the increase is \$.66 per ton, basically. And so, our commitment for this year is 4,200 tons is what we committed to for 2022. So, it'll be that additional amount per ton; \$.66 per ton.

<u>COUNCILWOMAN CREAMER</u> – Okay. We don't have a total amount? I know it's something we do annually. I just wanted to know a dollar figure of the impact.

BARB SYLVESTER - \$4,700.

COUNCILWOMAN CREAMER – Thank you.

COUNCIL PRESIDENT ISTNICK – Councilman Gregg.

<u>COUNCILMAN GREGG</u> – Thank you, Madam President. I'm sorry I wasn't here on Monday to discuss this. I mentioned before that I'm opposed to the amount of salt that our City uses on our streets. I'd hate to see the damage it does to our newly paved streets, to our cars, to our water supply. I'd like to see the City look into other ways to make our streets safe during the winter. I realize that is some places like hills and intersections that salt is required, but I think we use salt to a greater degree than necessary and to the detriment of streets and our environment. So, I would love to see the City look into other avenues. I'm not going to oppose this because I know it's probably the best pricing that we can get for the salt that we do buy. I just wish we'd buy less and use less. Thank you.

COUNCIL PRESIDENT ISTNICK – Anyone else? Councilman Thieret.

<u>COUNCILMAN THIERET</u> – Thank you, President Istnick. In that case, I move that we waive the rules requiring three readings and move Ord. No. 110 – 2022 forward for a vote tonight.

<u>COUNCIL PRESIDENT ISTNICK</u> – Seconded by Councilwoman Creamer. Roll call for suspension.

COUNCIL PRESIDENT ISTNICK – Councilman Lewis.

<u>COUNCILMAN LEWIS</u> – Yes. The next three proposed ordinances are in relation to the previous bids earlier in the year that came back high and then we had to pull them back and put them back out to bid to get them re-bid out so that we can move forward with these three projects. There's a slight increase on the appropriation that is needed from the initial appropriation that we did. So, that's what these next three are, so we can move forward on those projects. COUNCIL PRESIDENT ISTNICK – Councilman Lewis.

<u>COUNCILMAN LEWIS</u> – Yes. This ordinance is for \$150,000.00 appropriation for, as stated, for police overtime. As discussed, because we have been making efforts to fully staff our police department, as we continue to do so, our current officers are having to cover the additional shifts necessitating this appropriation. Are there any further questions or discussion this evening; my plans would be to move forward? Seeing none, I make a motion we suspend the rules requiring three readings, bringing Ord. No. 114 – 2022 forward for a vote.

<u>COUNCIL PRESIDENT ISTNICK</u> – Seconded by Councilman Lombardi. Roll call for suspension.

ORDINANCE NO. 115 – 2022 BY: FINANCE COMMITTEE

AN ORDINANCE making certain transfers in the 2022 appropriations from within the 1100 General Fund, for the year ending December 31, 2022, and declaring an emergency.

COUNCIL PRESIDENT ISTNICK - Councilman Lewis.

COUNCILMAN LEWIS – First reading.

COUNCIL PRESIDENT ISTNICK – Thank you. Ord. No. 115 – 2022 has received first reading.

RESOLUTION NO. 10 – 2022 BY: COMMUNITY DEVELOPMENT COMMITTEE

A RESOLUTION reversing the decision of the Massillon Board of Zoning Appeals in the Variance Case No. 2022-8.

COUNCIL PRESIDENT ISTNICK – Councilwoman Creamer.

<u>COUNCILWOMAN CREAMER</u> – Thank you, Madam President. As this states, the request is to reverse the decision that was made on June 23, 2022, by the Massillon Board of Zoning Appeals. There are three variance requests that were approved by the Massillon Board of Zoning. We heard from the applicant, Mr. Jason Welsch, this evening regarding the vacant parcel no. 603098 on Woodruff Avenue. He's requesting to build a new two-story with a loft, single-family dwelling. Are there any questions at this time from any Council members?

COUNCIL PRESIDENT ISTNICK – Councilman Lewis.

<u>COUNCILMAN LEWIS</u> – I understand the concern of maybe some of the appealing citizens in the area, however, this Council, I believe, has not heard any vocalized appeal. The only people that have shown up, I believe Mr. Vess has shown up twice now and shown maybe reluctant support, but support nonetheless and now the applicant has shown up. I haven't heard any outcry. So, I don't know why this Council would be incline to reverse the decision.

COUNCIL PRESIDENT ISTNICK – Councilman Thieret.

COUNCILMAN THIERET – Am I reading this right that the variance request is denied. So, if we reverse it, then he's allowed to do it?

COUNCIL PRESIDENT ISTNICK – Councilwoman Creamer.

<u>COUNCILWOMAN CREAMER</u> – No. The Massillon Board of Zoning approved the three variances on June 23, 2022 approved the three variance for this request on this parcel. We received letters from individuals that are requesting that we deny that appeal.

COUNCIL PRESIDENT ISTNICK – So if it passes?

COUNCILMAN THIERET – It's denied, but if we turn it down, then the variances are okay?

<u>COUNCILWOMAN CREAMER</u> – Correct. It'll move forward with the Board's approval for Mr. Welsch to build this single-dwelling house. My intent was to give it first reading tonight, but I wanted to make sure if we have any additional questions that can be answered tonight or any additional citizens that want to come to the next Work Session in person to voice their opinions, I welcome it.

COUNCIL PRESIDENT ISTNICK – Councilman Snee.

<u>COUNCILMAN SNEE</u> – Thank you, Madam President. I've spoken to most of the residents here and they've all appealed their appeals, basically. So, I don't see any reason to hold up anything, respectfully, I'd like to put it on tonight.

COUNCIL PRESIDENT ISTNICK – You're saying that the residents are okay with this?

COUNCILMAN SNEE – Right.

COUNCIL PRESIDENT ISTNICK – Anyone else? Councilwoman Harwig Smith.

<u>COUNCILWOMAN HARWIG SMITH</u> – I don't know if Mr. Johnson can address this or Jason Welsch, but when we talked about this before, we were told like variance no. 2, that he was already going to put it back 25 feet and then when he spoke tonight, it sounded like he was only going to leave it at 21 feet. Because I thought the biggest question was just like variance no. 1.

<u>JIMMY JOHNSON</u> – Good evening Council. I do not have the minutes from the Zoning Board in front of me, but, Mr. Welsch did state to the Zoning Board that he could set it back and just going by memory at this point and time, we did not give him that variance. So, if it would be needed I would have Mr. Welsch come back to the Zoning Board again, but he did agree that he could set that house back to the normal setback requirement off the road.

COUNCIL PRESIDENT ISTNICK – Which is 25 feet?

JIMMY JOHNSON – Yes ma'am.

<u>COUNCILWOMAN HARWIG SMITH</u> – I have one other question because they weren't sure when I asked the last time; so, the one side that has the wrap around porch which is on the second story, so the area that's 4 feet from the property line, is that the balcony or is that the structure of the house itself?

JASON WELSCH – That would be the balcony.

COUNCILWOMAN HARWIG SMITH – So the structure of the house itself is 8 feet away from the property line and you just have that little balcony that's sitting high above?

<u>JIMMY JOHNSON</u> – Yes.

COUNCILWOMAN HARWIG SMITH – Okay.

<u>JIMMY JOHNSON</u> – And has he said, those lots are such that the homes are doubled and so you're not going to be on top of one another.

<u>JASON WELSCH</u> – The balcony out there, it doesn't have a roof over it and my contractor was wondering that since it doesn't have the roof if that we part of the house or is that the property line; is that the front of the house or are they going to rule that in? He said a lot of time if it doesn't have a roof, they won't roll that in.

<u>JIMMY JOHNSON</u> – I would say that that will go to plan approval and if it's out of the variances granted that Frank will address it at plan approval.

COUNCIL PRESIDENT ISTNICK – Okay. Thank you.

<u>COUNCILWOMAN HARWIG SMITH</u> – So to clarify, since this was already approved by the Zoning Board, a vote "no" is that we agree with the Zoning Board and he can go ahead and build, correct?

<u>JIMMY JOHNSON</u> – Yes.

COUNCILWOMAN HARWIG SMITH – Thank you. I have no more questions.

COUNCIL PRESIDENT ISTNICK – Yes. Anyone else? Councilwoman Creamer.

<u>COUNCILWOMAN CREAMER</u> – Just to clarify, I believe I have four letters addressed to the Clerk of Massillon City Council that's requesting an appeal. I believe we've only had two or three individuals come to this Council and retract their appeal; two of them. Okay, so, there's two individuals still out there that have submitted a letter and that is my reasoning behind giving first reading this evening to ensure that any other individuals that want to come forward, they can come and voice their opinion. So, first reading.

COUNCIL PRESIDENT ISTNICK – Thank you. Res. No. 10 – 2022 has received first reading.

<u>COUNCIL CLERK ROLLAND</u> – Councilwoman Creamer. There were three original appeals. One from Sharon Rader, one from William Conti and one from Mr. Vess. Mr. Vess is the only one that revoked his appeal; he has done so in two meetings. He did it at the Work Session and he did it at the meeting tonight. Mr. Conti and Ms. Rader, I have not heard anything from since July 9, 2022.

<u>COUNCILWOMAN CREAMER</u> – Okay. Thank you for clarifying that.

COUNCIL CLERK ROLLAND – Yes ma'am.

COUNCIL PRESIDENT ISTNICK – Thank you. Res. No. 10 – 2022 has received first reading. Res. No. 11 – 2022.

RESOLUTION NO. 11 – 2022 BY: FINANCE COMMITTEE
