7. INTRODUCTION OF ORDINANCES AND RESOLUTIONS

ORDINANCE NO. 163 – 2021 BY: COMMUNITY DEVELOPMENT COMMITTEE

AN ORDINANCE repealing Ordinance No. 118 – 2011, which subdivided the City of Massillon, Ohio, into wards and enacting a new Ordinance subdividing the City of Massillon, Ohio, into wards, and declaring an emergency.

COUNCIL PRESIDENT ISTNICK – Councilwoman Starrett.

<u>COUNCILWOMAN STARRETT</u> – Thank you, Madam President. I do intend to give this ordinance first reading tonight, but I do want to point out to Council members that Section 3 does not have the full description it needs to redistrict ward and that yet is due to some questions and concerns that were voiced at the last Work Session and just in case we make any changes, they didn't want to type out the big long description of wards until we are sure that this is what we want to do. So, at some point we will have to amend Section 3 prior to voting on this. So, that's why you don't see the description in there in case anybody had any questions. So, we can talk about this at the next Work Session and, first reading.

<u>COUNCIL PRESIDENT ISTNICK</u> – Thank you. Ordinance No. 163 – 2021 has received first reading. Ord. No. 164 – 2021.

ORDINANCE NO. 164 – 2021 BY: COMMUNITY DEVELOPMENT COMMITTEE

AN ORDINANCE authorizing the Director of Public Service and Safety of the City of Massillon Ohio, to advertise for and receive sealed bids and to enter into a contract with the lowest and best bidder, upon the approval of the Board of Control, for the Charles Street Improvement Project in the City of Massillon, Ohio, and declaring an emergency.

COUNCIL PRESIDENT ISTNICK – Councilwoman Starrett.

<u>COUNCILWOMAN STARRETT</u> – Thank you, Madam President. This ordinance does deal with the Charles St. Project. It is just the last step so we can get moving and get started on that project and get bids out. Any questions or concerns? Council has already approved this project to go forward. AN ORDINANCE authorizing the Director of Public Service and Safety of the City of Massillon, Ohio, to advertise for and receive sealed bids and to enter into a contract with the lowest and best bidder, upon the approval of the Board of Control, for the Getz Building Reconstruction Project in the City of Massillon, Ohio, and declaring an emergency.

COUNCIL PRESIDENT ISTNICK – Councilwoman Starrett.

<u>COUNCILWOMAN STARRETT</u> – Thank you, Madam President. Again, this is the same as the prior ordinance. We have passed the project already. This is just the last step to get into contract to get this project started for the Getz Building. Any questions, comments, concerns? Seeing none, I make a motion that we waive the rules requiring three readings and bring Ord. No. 165 – 2021 forward for a vote.

ORDINANCE NO. 166 – 2021 BY: PARKS AND RECREATION COMMITTEE

AN ORDINANCE authorizing the Director of Parks and Recreation, on behalf of the Massillon Recreation Board, to conduct the process of selecting and entering into contract with a design-build firm/contractor for the design-build services for the City of Massillon Parks and Recreation Park Pavilion Construction Project, and declaring the same to be an emergency.

COUNCIL PRESIDENT ISTNICK – Councilwoman Litman.

<u>COUNCILWOMAN LITMAN</u> – Thank you, Madam President. This is a request to begin the phase of entering into contract for the Lincoln Park on 17th St. Pavilion. We've talked about this previously with Mr. Pedro here. This is something that has been in discussion for quite some time, so, this is something that I'd like to move forward as quickly as possible, if we can. This has been approved by the Recreation Board and it indicates a 4 – 0 vote and one member was actually absent at that meeting. So, this is something that I'd like to try to move forward so, I'd like to suspend the rules requiring three readings and put Ord. No. 166 – 2021 forward for a vote.

COUNCIL PRESIDENT ISTNICK – Councilwoman Litman.

<u>COUNCILWOMAN LITMAN</u> – Thank you, Madam President. Again, Mr. Pedro was here last week at our Work Session to discuss why he felt the need for the increase was appropriate. I certainly agreed with that, as well as Mrs. Creamer. So, we will also look forward to putting this up for a vote this evening if there is no further questions or discussion. Seeing none, I'd like to waive the rules requiring the three readings and put Ord. No. 167 – 2021 forward for a vote.

ORDINANCE NO. 168 – 2021 BY: RULES, COURTS AND CIVIL SERVICE COMMITTEE

AN ORDINANCE amending the OCCUPATION LIST OF CLASS TITLES, 705 – 730 HEALTH DEPARTMENT, PART/TIME/TEMPORARY/SEASONAL, and the MISCELLANEOUS SCHEDULE in the City of Massillon, Ohio, and declaring an emergency.

COUNCIL PRESIDENT ISTNICK – Councilman Gregg.

<u>COUNCILMAN GREGG</u> – Thank you, Madam President. This is an ordinance we talked about in Work Session. The Health Department wants to use some COVID related funds to hire some additional employees. So, they've got the funding for it, they've got the positions ready for it; they've asked for this to be passed as quick as possible so that they can get those employees on board. First of all, I'll ask if there are any questions or concerns? Alright, I'd like to make a motion that we waive the rules requiring three readings and bring Ord. No. 168 – 2021 forward for a vote.

<u>COUNCILMAN LEWIS</u> – To clarify, there's no need for the President to make a tie breaking vote. It failed to meet the standard to get suspended, so, it just gets first reading at this point.

COUNCIL PRESIDENT ISTNICK – Thank you; that was my question. So, first reading for Ord. No. 168 – 2021. My question would be then, if this were third reading?

COUNCILMAN LEWIS – If it were third reading, that would have been the actual vote and you would have made a tie breaking vote.

COUNCIL PRESIDENT ISTNICK – Thank you. Ord. No. 168 – 2021 has received first reading. Ord. No. 169 – 2021.

ORDINANCE NO. 169 – 2021 BY: RULES, COURTS AND CIVIL SERVICE COMMITTEE

AN ORDINANCE amending the PARKS AND RECREATION PART-TIME/TEMPORARY/SEASONAL WAGE RATES in the City of Massillon, Ohio, and declaring an emergency.

COUNCIL PRESIDENT ISTNICK – Councilman Gregg.

<u>COUNCILMAN GREGG</u> – Thank you, Madam President. This ordinance we discussed in Work Session and Mr. Pedro is here. It is to increase the wages of the lower level employees

and to make it more competitive and make it possible to perhaps hire some more employees to the Parks and Recreation Department. Are there any questions, concerns or thoughts? Seeing none, I make a motion that we waive the requirements for three readings and bring Ord. No. 169 – 2021 forward for a vote.

COUNCIL PRESIDENT ISTNICK – Councilman Lewis.

<u>COUNCILMAN LEWIS</u> – Yes. This is the \$50,000 for the HOME Fund. It is to assist with the assistance to qualified low to moderate income households in need. It is a fund that we typically do make sure we keep funded and get these out to the people that will utilize them in the community. Are there any questions or discussion? COUNCIL PRESIDENT ISTNICK – Councilman Lewis.

The money was gained or brought to the City through an effort of the Street Dept. cleaning up some waste equipment that was in the yard of the garage and being able to get it turned in. COUNCIL PRESIDENT ISTNICK – Councilman Lewis.

<u>COUNCILMAN LEWIS</u> – Yes. This is similar to the last one that we did, except this is going to be out of the Street Construction M & R fund, but it is related to income tax refunds. Are there any questions or discussion this evening? Seeing none, I make a motion that we suspend the rules requiring three readings, bringing Ord. No. 173 – 2021 forward for a vote.

AN ORDINANCE authorizing the Law Director to execute the Participation Agreement for the OneOhio Subdivision Settlement with Janssen/Johnson&Johnson pursuant to the OneOhio Memorandum of Understanding regarding the pursuit and use of potential opioid litigation settlement funds and consistent with the material terms of the July 21, 2021, proposed Settlement Agreement; also authorizing the Law Director to execute all other necessary documents and take all other appropriate actions related to the settlement of any claims concerning Janssen/Johnson&Johnson; and declaring the same to be an emergency.

COUNCIL PRESIDENT ISTNICK – Councilman Lewis.

<u>COUNCILMAN LEWIS</u> – Yes, if I could have the Law Director, please.

COUNCIL PRESIDENT ISTNICK – Mr. Richard, if you'd come up. Thank you.

<u>JUSTIN RICHARD</u> – Madam President, Council Members. This is certainly a new defendant but not a new thing. This is similar to the "Big Three". What I am asking today is, we do have a deadline. It is this week and we did, or you, oversaw an amendment to the agenda this evening. We're asking that either this be moved, for voting purposes, after the Executive Session because we would like a vote this evening. This would, of course, allow us to enter into the agreement similar as we have in the past, but we would, before you vote on it, of

course, like to discuss the particulars of that ongoing litigation. Because it is ongoing litigation, it should be discussed in Executive Session.

COUNCIL PRESIDENT ISTNICK – Councilman Lewis.

<u>COUNCILMAN LEWIS</u> – Yes. I should have included that in my initial motion. So, with that said, I would like to make a motion that we amend the agenda to place Ord. No. 174 – 2021 after Item #17 at the conclusion of the Executive Session.

COUNCIL PRESIDENT ISTNICK – Seconded by Councilwoman Starrett. Roll call.

<u>COUNCIL PRESIDENT ISTNICK</u> – Thank you. Ord. No. 174 – 2021 will be voted on after the Executive Session which is after Item # 17.

COUNCIL PRESIDENT ISTNICK – Mr. Gregg, I apologize, it should have been done at the beginning of the meeting.

<u>COUNCILMAN GREGG</u> – Thank you, Madam President, no problem. I appreciate you remembering. I just wanted to give a shout-out to the Massillon Tiger football team for another great victory on Friday night. We took down previously undefeated Big Walnut who is the No. 1 seed in the region and they play this Friday night at Mansfield, as of now, against Green, our neighbors to the north. So, just a shout-out to them. I wish them good luck. They've represented the City very well and "Go Tigers".

COUNCIL PRESIDENT ISTNICK – Go Tigers. Councilman Lewis.

COUNCILMAN LEWIS – I just have some unfinished business, if that's okay?

COUNCIL PRESIDENT ISTNICK – Sure. That's where we are.

<u>COUNCILMAN LEWIS</u> – At last week's Work Session, we did have two budget adjustment transfers that we were asking for additional information on before we could sign and I just wanted to call up the Budget Administrator to give us the explanations that we requested.

<u>COUNCIL PRESIDENT ISTNICK</u> – Okay. Ms. Kotagides-Boron, if you'd come up. Thank you.

LORI KOTAGIDES-BORON – Good evening, everybody. I just wanted to clarify; this is legislation that was left from last week, the budget transfers. There was one to services and contracts; that was in the 1100.415, that was the Building Dept.; that was to cover extra salary for code enforcement, things that they'll be doing during the training period. So, that is some of the things that will, basically cover. We have a new code enforcement gentleman who is training right now. So, it's putting a little bit more on Jimmy. And then the 1220.415, which is actually the transfer there, is just for code enforcement activities. So, that is more or less when you have the dumpsters or have yard clean-up or anything like that, we reach out and do code

enforcement and help the community; so, that is what that transfer to services and contracts are.

COUNCIL PRESIDENT ISTNICK – Any questions? Councilman Lewis.

COUNCILMAN LEWIS – So I just want to clarify that the \$9,000 one out of the 1100 fund is to cover the cost of one of the code enforcement officer to provide training to another?

LORI KOTAGIDES-BORON – Yes.

COUNCILMAN LEWIS – And that's until the end of the year?

LORI KOTAGIDES-BORON – Yes.

COUNCILMAN LEWIS – So, \$9,000 for six weeks?

<u>LORI KOTAGIDES-BORON</u> – There may be some more involved in that; I do know that we're running a little bit short because Jimmy has been working extra hours through the year, as well. So, it's not a "pure" \$9,000 to the end of the year, but it is also to cover the shortage for the extra hours that he's been working.

COUNCIL PRESIDENT ISTNICK – Councilman Thieret.

<u>COUNCILMAN THIERET</u> – Yes, I was just wondering if we could get an update on the crosswalk signs in downtown?

COUNCIL PRESIDENT ISTNICK – Thank you, Mayor.

<u>MAYOR CATAZARO-PERRY</u> – Good evening, Madam President, Members of Council. Jason Popiel will be here on November 29th with the final decision.

COUNCILMAN THIERET – Thank you.

Treasurer's Report - October 2021 Mayor's Report - October 2021

COUNCIL PRESIDENT ISTNICK – Thank you. Mayor.

MAYOR CATAZARO-PERRY – Good evening, again. My report this evening for Council update; Contract I for the streets is completed. Contract II will be completed in one to two weeks. The levy project continues throughout this winter and the Patriotic Committee brings the Massillon Holiday Parade this Saturday. The line-up is at 4:00 p.m. and the parade takes off at 5:00 p.m. And I wanted to give you an update on the income tax for the year, you also received this through the Mayor's reports. Year-to-date, income tax received close to 2020/2021 was \$19 million and in receipts posted was an increase from 2020 of \$1.9 million, which is a positive of 11%. Thank you.

COUNCIL PRESIDENT ISTNICK – Mayor, just off note, what time is the parade Saturday?

MAYOR CATAZARO-PERRY – 5:00 p.m. Line-up is at 4:00 p.m.
