<u>COUNCIL PRESIDENT ISTNICK</u> — Madam Clerk, are the minutes of the previous meeting transcribed and open for public viewing?

**COUNCIL CLERK ROLLAND** – Yes, they are.

## 5. REMARKS OF DELEGATIONS AND CITIZENS TO MATTERS ON THE AGENDA

GEORGE GLIBA – I live at 222 Lake Ave. N.E., Massillon, OH. I am a Massillon resident and taxpayer. This is about Ord. No. 91 – 2018. We got our Parks Director right here to my left. This is pertaining to that \$150,000 he's asking for. Now he said three to four weeks ago that he wanted to clear out that west bank over there on Reservoir Dr. But, previously, I talked to him down at the Rec. Center and he does have a vision for Sippo Reservoir Park, I'm not going to discredit that. He said it would be a year or two years down the road, there's a plan. But the plan he has about clearing out that west bank I have an issue with because I've been up here before about a geese problem and when I first came up here this year, I said I ain't going to talk about them geese anymore. I said, nobody's going to do anything and push come to shove, somebody might. But, I talked to him about the dogs roaming the park. Two years ago, he said that that could be a possibility; we ought to look into it. Now there's companies that do that. They have Ohio Geese Control and they have another outfit that could probably take care of the situation. But, when I said that to him over at the Rec. Center, he said it doesn't work. The Mayor said it doesn't work. It doesn't work because it takes time.

There's over a hundred and fifty geese down there. It's going to take time. If you wanted to get them out there, you'd get them out of there. But my problem is that if you clear out that west bank, it's going to create more geese. You might as well rename it Sippo Geese Park because that's what it's going to be. You cleared that out, there's going to be more geese over there than there are now because that's what they do. They eat grass and they crap all over the place. So, it could turn into a real mess over there. But, I want to keep it at three minutes, so, I better stop now while I'm getting close. But, anyways, maybe Steve can reply to it later, but I just think it's a big mistake to clear that out because in another couple of months, it'll be dormant. You can go in there and take your chain saws and your hatchets and do it yourself and save the City some money, but then on the other hand, we don't know how firm the soil is. That might take years to solidify. We have our expert here tonight on that, I think, the soil over there. But anyways, I just wanted everyone to rethink clearing that out and what's that's going to create over there. Just more opportunity for geese to live and breed and multiply. Thank you for your time.

AN ORDINANCE amending Section 2(D) OCCUPATION LIST OF CLASS TITLES of Ordinance No. 127 – 1997 by eliminating the 175 "HUMAN SERVICES DEPARTMENT" and merging the position of Equal Employment Opportunity Compliance Officer with the Civil Service Administrator under 150 "CIVIL SERVICE COMMISSION", and enacting an increase to the Class Grade pay schedule within the 150 "CIVIL SERVICE COMMISSION", in the City of Massillon, Ohio, and declaring an emergency.

#### 17. REMARKS OF DELEGATIONS AND CITIZENS TO MATTERS NOT ON THE AGENDA

<u>PATRICK BAGLEY</u> – 1316 Tremont St. S.W., Massillon, OH. My issue is Scott Graber. Something needs to be done with this. I am the owner of the Oldtimer's Bar & Griddle. We are losing business because of him and we need to know what we have to do to come to some kind of conclusion on what's going to be done with this matter. The police has been up there numerous times in the last week, but no arrest has been made and destroying vehicles and

pulling a shotgun on a motorcycle going down the road. Making death threats over social media and nothing is getting done over this matter. Thank you.

**COUNCIL PRESIDENT ISTNICK** – Don't forget to sign the paper. Anyone else from the audience?

<u>ROB EDMINSON</u> – 11 – 8<sup>th</sup> St. S.W., Massillon, OH. I live on 8<sup>th</sup> St. and this Graber guy is doing all this stuff right around the corner and my son, I got a big house and duplex; he lives above me. I have a 9-yr. old grandson. There are numerous children in this neighborhood. I mean, you got to really watch. I was okay with this when he was bitching about the speeding and traffic lights and all that stuff. It's kind of hard to not know what this guy's doing up here, but now, he's got guns on the porch and he's physically blowing air horns and all kinds of stuff. He's insighting this now and I'm just here to make a record that something needs to be done because if this gets out of control and if there's a child hurt, something's going to be done.

#### **COUNCIL PRESIDENT ISTNICK** – Anyone else?

SCOTT KIM – 1117 North Ave., Massillon, OH. Mr. Graber, I didn't even know this man, I still don't; only because of what had happened. I was riding my motorcycle home, probably about a year and a half ago. That's when the four-way stop was still there. I was coming to a stop and I noticed out of the corner of my eye, a man which I found out later was him (Graber), I think it was a styrofoam cup and I noticed out of the corner of my eye as I was coming to a stop, he went like that. As I turned around after I stopped, he's walking back off the street. I realized that he just threw something. I thought he was throwing his coffee in the street or something and then after that, I started hearing all these other reports that he's out there throwing coffee on people riding motorcycles. Somebody is going to get hurt and like this man said, it's going to get out of control. Someone is going to get hurt. Something's got to be done. How can he threaten to blow people's heads off on social media? It's right there for everybody to see. It's just getting worse and worse and worse. Massillon Police are up there all the time. I know their hands are tied on what's legal and what's not, but somebody's really going to get hurt.

### **COUNCIL PRESIDENT ISTNICK** – Thank you, Scott. Is there anyone else?

CAROL GEIER - I live at 880 Sippo Blvd. N.E., Massillon, OH. We have property; our frontage sits over the walking path and we've been there fifteen years. We came to City Council to get permission to build there. Our driveway, to bring our driveway down at the edge of our property, I'm sorry, I'm trying to explain our set-up here. If we went straight out, we would have run right onto the walking path, so, the City gave us permission to go down our driveway and to the right. Now, the people next to us, they want to build and use the easement part of our driveway. Which would not have been a problem even if they would have asked to use it if we had just gone straight down. So, our concern is we don't want to do this. There's the safety issue because we have a very steep driveway. They want to come in right at the curve of our driveway. The maintenance, I'm concerned about. A maintenance agreement, I don't even know what that would look like which we could shovel every other time which really doesn't make sense to me. And then, that is our only possible to put the driveway because we do run along the walking path where the other property, their entire frontage, sits over the parking lot. So, we're talking to an attorney just because we need to protect ourselves and our interest. He said resale value is a very big thing. A lot of banks don't want to deal with shared driveways or anything. So, I just wanted to make it a point that we're running into this issue. We did what the City asked and now we're being asked to share. So, I just want to... I've talked here. I've been down to the Civil Engineer office also. So, I just wanted to touch base with you guys also. And, I'm sorry it's a little confusing because of where our property sits. But, thank you.

<u>COUNCIL PRESIDENT ISTNICK</u> – Thank you, Carol. Is there anyone else that would like to come forward and speak?

TAMMY MACKEY — I live at 49 — 21<sup>st</sup> St., Massillon, OH. I just want to say that something has got to be done with Scott Graber. I live maybe a street and a half over from him. My daughter's friend, who last week, went to visit a friend of his that lives on Scott's street. He'd never been there before. Drives a motorcycle. He lives clear down by Giant Eagle, so, he doesn't even know who Scott Graber is. So, of course, he was riding his motorcycle and he couldn't find his friend's house and so, my daughter's friend was going up and down the street trying to find this house. Well then, Scott Graber started screaming and hollering at him. Next

thing you know, Scott Graber pulled out his gun and put one barrell in a shotgun and pointed at my daughter's friend. All because he was driving up and down the road looking for a friend's house. This kid is 20 yrs. old. Doesn't even know who Scott is. And then, we're hearing from different people that we Scott to calm down. I'm sorry, but, Scott is playing a game and Scott is not dumb. I have a bad feeling in my gut that this is the calm with Graber before the storm. The guy knows what he's doing. He's threatened to blow people's heads off. His neighbor, he threatened his neighbor on video that he was going to blow his head off. If that was a kid in a high school, they'd be sitting out at Faircrest. If that was an adult, we'd be sitting at Stark County Jail. So, why can't we get answers as to why nothing is being done with Scott. We need answers as a community. We pay our taxes. We don't cause havoc in Massillon. Why should he be allowed to get away with what he's getting away with? Thank you.

COUNCIL PRESIDENT ISTNICK - Thank you, Tammy. (Applause). Anyone else?

AMY TENLEY – 1227 Tremont Ave. S.W., Massillon, OH. I live right across the street from Graber. I got grandkids at my house all the time. It's bad enough that he blasts me on Facebook and You Tube all the time talking crap about me. But now, like they said, he's coming out with a gun and everything else. I can't even sit on my front porch because as soon as I do, he's out there with his video camera on me and my house. My grandkids are out there. He's got that camera out 24/7, most of the time and it's just when he goes on his little tirades, coming off the porch yelling and screaming and just freaking out, then I have to take the grandkids into the house because I don't know what he's going to do. So, just like they said, something's got to be done because it's a harassment. It's every day, all day. That's all.

<u>COUNCIL PRESIDENT ISTNICK</u> – Thank you, Amy. Anyone else? I'd like to thank you all for keeping your comments brief and in appreciation of that, which is what we don't usually do; this is not a question and answer, but I am going to call Andrea Scassa up and maybe she could just give us a little bit of information.

ANDREA SCASSA — Thank you all for coming out. It has been, to say the least, a scary few days with what has been posted. Our office and my Chief Prosecutor is here this evening, has received police reports, we've seen the posts and, although, we do not go out as the Police Dept., we get it at that point. I would say that, Ma'am, the incident with your daughter's friend, at any time, if something like that happens, you do need to call the police and make a police report about it. Our office will get any police report that is filed and made with the Massillon Police Dept. and it will be under review. Other than that, I can't really speak to any reports that have been filed, to date. I can't answer any questions, ma'am, but, like I said, I understand that toward the end of last week, the comments that were being made on social media are scary. I'm not trying to discount that, but as one of the individuals mentioned, we still have to work within the confines of the law. So, at any time, when you feel threatened, I would advise you to call the Massillon Police Dept. and there's not much more I can say about the reports that have been filed, to date.

BRENDA WEAVER - And we do and they do nothing, I'm sorry.

<u>ANDREA SCASSA</u> – Well, I can't speak for the police dept. but I know our officers handle things with professionalism.

**BRENDA WEAVER** – Does somebody have to die before something happens?

ANDREA SCASSA – Ma'am, I can't answer to that.

<u>TAMMY MACKEY</u> – Just in regards to what you had said about my daughter's friend calling the police. They did call the police.

**ANDREA SCASSA** – Okay.

<u>TAMMY MACKEY</u> — They did call the police and Massillon PD does an amazing job, in my eyes. I don't know about everybody else, but in my eyes, they do fine. However, we're hearing that it's the prosecutors, it's the prosecutors. Let me finish. Massillon's doing what Massillon needs to do, it's the prosecutors. So, my question is, what is taking you guys so long to do something with this man? Because, like I said, it's the calm before the storm. He's not a dummy and something bad is going to end up happening to somebody and then what happens? The City of Massillon gets sued? We don't need to go that far. Do something with the man; pink slip him, something.

<u>ANDREA SCASSA</u> – Ma'am there is a process that we have to go through and, like I said, as we get the police reports, we do deal with them.

TAMMY MACKEY — I understand that and I get that there is a process. But, when a child goes to a school and a child on social media threatens to shoot up a school, there is no process. That process is you instantly go and arrest that kid. He is sitting in the DH until you figure out what the problem is. This guy is running free while you're figuring out the problem and something's going to happen. I'm sorry, but I'm upset about it. My kid drives down that road innocently to go to work and she is on his video camera. Who's to say that he don't shoot my kid? I don't know how may kids you have, but I have one. So, if something happens to my kid while she's driving down that road, I can't replace her. I'm just saying. I'm pretty irritated. But, if somebody were to go up to his house and threaten him or knock his daylights, say me, I'm going to jail. But he can do anything he wants to terrorize the neighborhood. That's not okay.

BRENDA WEAVER - Can I say something?

### **COUNCIL PRESIDENT ISTNICK** – Yes.

BRENDA WEAVER - Everybody's scared to call the cops because this guy knows the law and he knows what he's doing and he knows how to manipulate it. So, he's doing everything he can and working against everybody else. But, everybody's scared to call the cops because, we're afraid of getting in trouble over stupid stuff. Like riding down the road or driving down the road. My sister lives across the street with my nieces and nephews and he's got guns on the porch. This is ridiculous. It's escalating and escalating and escalating to the point where this guy has guns on his porch. It's bad enough that he's got a video camera taping your privacy. Now he's got guns and he's threatening to shoot people as they go by. Let alone the stuff he does to the biker's that drive by. Throwing things at them, throwing shit in the road and causing an accident or killing somebody. Airhorns, they drive by, airhorns. A loud car goes by, he calls 24/7 and it is ridiculous, it is ridiculous. I do not see how this is not harassment. Something needs to be done. He's mental and he's escalating and it needs to be taken care of. Thank you.

**COUNCIL PRESIDENT ISTNICK** – Ma'am, did you sign the sheet?

**BRENDA WEAVER** - I will.

**COUNCIL PRESIDENT ISTNICK** - Thank you.

<u>PATRICK BAGLEY</u> – I got another question. I know you guys can't answer this question, but here's the thing of it is. There was a car going down the road the other day. This man comes off his porch and throws a metal bar through the guys back door car window. How did he not go to jail? Me, I wouldn't have made it back inside the house and I would have been in handcuffs and down here in the City and out to Stark County.

## **COUNCIL PRESIDENT ISTNICK** – Were the police called?

PATRICK BAGLEY - Yes, they were. There is a police report on it. There is also a police report on all of these comments, death threats. There is also a police report and if you actually look on Facebook you will actually see where the cops were standing on his porch talking to him the day that he pulled a gun on that rider, on that rider that went by his house. And what's this officer say to him, the last officer, you're doing the right thing. You're just doing it the wrong way. Also, I have went over, bent over backwards to keep this man off of my business. I understand, yes, we had motorcycles parking on the sidewalk. But I have three sidewalks. We were keeping people against the building or against the curb. Leaving the fringe open. We ended up marking the street, marking the side off "No parking". Hang signs up and put cones across the street for the bikers to park, for the riders to park. We have one video and there is also a police report over it, where he goes down the road and intentionally runs our cones over. When we're doing this stuff to make him happy and now the last thing that happened, the City of Massillon Safety Director came up and told us that we are not allowed to put the cones on the road because the road is dedicated for car parking. So, what, my motorcycles, where are they supposed to park, my riders? My paying customers; where I'm losing money over this and if I'm not allowed to put cones on the road, how did the Billings get away with it for so many years? Thank you.

**COUNCIL PRESIDENT ISTNICK** – Anyone else?

<u>TAMMY MACKEY</u> – I just have a question. So, you're recording this, which I'm okay. I don't care. But, because this stuff goes online. So, is my address going to be on that, so that now, Scott Graber knows where I live?

<u>COUNCIL CLERK ROLLAND</u> – It's public record.

**COUNCIL PRESIDENT ISTNICK** – It's public record.

**TAMMY MACKEY** – So then, what if I have a problem on my property? That's okay.

<u>COUNCIL PRESIDENT ISTNICK</u> – I appreciate you all coming out and voicing your concerns and hopefully something will come out of this. And again, if it continues just filing the police reports. That all, at this point, that we can do. I appreciate it. Councilman Manson.

<u>COUNCILMAN MANSON</u> – I want to make a motion that we enter into Executive Session pursuant to ORC Section 121.22(g)(8) for the consideration of confidential information related to marketing plans, specific business strategies, trade secrets and financial statements with regard to applications and proposals for economic development assistance. This economic development assistance will be administered through the Community Improvement Corporation of Massillon and this Executive Session is necessary to protect the interest of the applicants as well as a possible investment and expenditure of public funds made in connection with this economic development project.
