On a motion by Cathy Heitger, and seconded by Dr. Sonia Ullum, approval was given to pay the February bills for the Health department in the amount of \$20,772.70 and for the WIC department in the amount of \$10,890.53 for a total amount of \$31,663.23 for February 2021. 1. Announcement of equity message

3. Transfer of announcement and approval of benefits
 - a. Civil Service has provided us an employee for the Registrar position. This will be a transfer from the Safety/Services Division to the Health department. It is Anita Combs who comes to us with 15 years of experience with the city as executive assistant to the Safety/Services Director, and the Engineering Department before that. She already knows billing, payroll, website design, etc. She will require minimal training of 3-4 days on birth and death records. She has a BA in business. She is already at the 12S level, we just need to approve her transfer of benefits at the 12S, 15 year level for salary and benefits. On a motion by Cathy Heitger, and seconded by Dr. Sonia Ullum, approval was granted for the transfer of salary and benefits. Motion carried.


