1. On a motion by Dr. Sonia Ullum, and seconded by Cathy Heitger, approval was given to approve the August 2021 meeting minutes as mailed. Motion carried.

2. On a motion by Cathy Heitger, and seconded by Jeff Thornberry, approval was given to pay the August bills for the Health department in the amount of \$26,486.92 and for the WIC department in the amount of \$12,749.59 for a total amount of \$39,236.51 for August 2021. Motion carried.

Old Business

1. COVID-19 update

2. Approval to accept a grant from Massillon Rotary

- a) The Massillon Rotary has presented us with a grant for \$5,860.00 to conduct a community baby shower to improve infant mortality incomes in our community. Erin Wise described some details of the baby shower. On a motion by Ann Palaski, and seconded by Cathy Heitger, approval was given to accept the grant from the Massillon Rotary. Motion carried.

3. Review of Senate Bill 22 and what that means for Local Health Departments

- a) Senate Bill 22 provided State Legislature with the authority to cancel health orders lasting longer than 30 days. Orders cannot be renewed for 60 days. The law also created a legislative panel to oversee Health orders and restricted local authority to quarantine without a medical diagnosis. See attached.

4. Approval to purchase a printer

- a) The Massillon City Health Department would like to purchase a large capacity printer for Birth/Death certificates and Food Service blueprints. The price is \$5,271.00 and will be paid with grant money. 

Senate Bill 22 Overview

Senate Bill 22 became a law on March 24, 2021. The law provided the legislature with the authority to cancel health orders that last longer than 30 days and required the governor to renew such orders every 60 days. The law also created a legislative panel to provide oversight of the governor's health orders and restricted local officials' authority to require people to quarantine without a medical diagnosis.

This ruling applies to Local Health Department as well as ODH and the Governor to limit orders such as isolation, quarantine, and shut downs for health reasons. This appears to be in response to the shut down and mask mandate orders from 2020.

A good example of the danger of this bill would be the Ebola incident that occurred several years ago. A quick response from health authorities closed businesses and quarantined plane passengers that were exposed to a passenger from Ohio that later tested positive.

The bill is the response from Republican majorities in both the House and Senate to the perceived overreach by Governor DeWine during the pandemic.

Timeline

- **February 17, 2021:** Passed the Senate 25-8.
- **March 10, 2021:** Passed the House 57-38.
- **March 23, 2021:** Gov. DeWine vetoed Senate Bill 22.
- **March 24, 2021:** The Ohio legislature voted to override Gov. Mike DeWine's (R) veto of Senate Bill 22. The Senate voted 23-10 to override the veto, while the House voted 62-35 to do the same.
