<u>COUNCIL PRESIDENT ISTNICK</u> – Thank you, Councilman Snee. Madam Clerk are the minutes of the previous meeting transcribed and open for public viewing?

COUNCIL CLERK ROLLAND – Yes, they are.

COUNCIL PRESIDENT ISTNICK – Are there any additions or corrections to be made?

COUNCIL CLERK ROLLAND – No, there are not.

5. REMARKS OF DELEGATIONS AND CITIZENS TO MATTERS ON THE AGENDA

GEORGE GLIBA – 222 Lake Ave. N.E., Massillon, Ohio. I wanted to weigh in on the building that's being torn down, Tiger Rags store. I wanted to weigh in on that. I was here during the

discussion that night way back, I think January 2nd and Lewis had said that he's getting some calls that the people that are getting the building torn down that they don't have any "skin" in the game. Now, they came up here and talked for several minutes and they said that they've been here for 45 years, a staple to the community, Tiger Rags. They put \$40,000 in the building to try to save it. So, for somebody to say that, really doesn't know that they're talking about because I think they did have "skin" in the game. They tried to save the building and they've probably given back to the community ten-fold, who knows. Only they know that for sure. And then, I read in the paper that the guy in Ward 2, Violand, he said that they should give the right to some benefit and I don't get it. 45 years at staple in the community, they tried to save the building and this Council is wanting not to give them the money that they've already been granted. Theoretically, they've been granted the money through the Governor. The Governor DeWine; they got a letter from the governor; here's the money then we have safety issues. The building has safety issues. Lewis spoke a couple of weeks ago about it. He's concerned about the community; it could fall down, it could fall down tomorrow, who knows. But anyways, I would think that with what they've put into the building and been there 45 years and been granted the money, basically. And it's not a cost to anybody any money. I mean, it's State money; very minimal. I mean, that's what State money's used for. It's for projects within the community. So, they've been granted the money and I've been up here several times. There's been some big decisions like Sippo Reservoir Park. The community got involved because it was such a big issue. Now, if it's such a big issue for nine people to make a decision, why isn't there an open forum up here for the community to come up here and speak on behalf of this building? The same thing happened with the amphitheater. It was a big issue. People were in a tough spot. I mean, it's tough to see. But, there was an open forum for that too. So, I think they should get the money and get the building torn down and guit dragging your feet about it. I mean, come on. What if that was you? That's the way I think about things a lot of times. What if that was you? What if that was your building? Would you be saying this? No. Just give them the money and get it torn down. And another thing; Herncane asked them what they were going to do with the property? That was a big question to ask. They said they were going to keep it. So, what does that tell you? They're going to reinvest. They're not going to sell it. But that's what I had to say?

The developer that is doing this is also the developer that is developing the Starbucks property across from Home Depot. I think they do a fantastic job. I think that this is a good use of this property and I would, again, urge this to be passed. Thank you.

AN ORDINANCE authorizing the Mayor of the City of Massillon, Ohio, to enter into an agreement with Cyrus Ausar to provide an economic development "inducement grant" to fund start-up costs, including build-out, equipment, etc., for Grow Mental Health & Wellness, located at 141 – 1st St. N.E., Massillon, Ohio, and declaring an emergency.

COUNCIL PRESIDENT ISTNICK – Councilman Herncane.

<u>COUNCILMAN HERNCANE</u> – Thank you, Madam President. Are there any questions tonight on this ordinance? Seeing none, I make a motion that we bring Ord. No. 177 – 2022 forward for a vote tonight.

COUNCIL PRESIDENT ISTNICK – Seconded by Councilman Violand. Roll call.

COUNCIL PRESIDENT ISTNICK – Thank you, Madam Clerk. Ord. No. 177 – 2022 has passed. Ord. No. 184 – 2022.

ORDINANCE NO. 184 – 2022 BY: FINANCE COMMITTEE
Tabled January 3, 2023 until January 17, 2023

AN ORDINANCE making certain appropriations from the unappropriated balance of the 1100 General Fund, for the year ending December 31, 2022, and declaring an emergency.

COUNCIL PRESIDENT ISTNICK – Councilman Lewis.

COUNCILMAN LEWIS – Yes. This particular ordinance had a lot of discussion around it and we have in the past week received some additional information. I believe we were all able to receive information in regards to a potential business deal that the property owner was negotiating for future use of the property be a local investor which is always a positive thing to see. We also received tonight this letter from the property owner. A lot of good information and in some ways he does summarize some excellent points and that there is a variety of opinions in discussion and looking for clarity on how best to use this. From my understanding, so far, we are in a situation in which the State does have a program in which a property such as this did qualify for and can be torn down for the safety and revitalization of our downtown and this grant is a 100% reimbursable grant that can be made. In this letter that we received, it is stated that the property owner, on page 2, paragraph 2, in the last sentence it says "We have proposed that the City is unwilling to fund the grant. We can fund the grant which would then be reimbursed to the City of Massillon who would then reimburse us". To me, that sounds as if the property owner is stating that they are willing to put up the cost, the up-front cost of the tear down of the property and then just pull the State dollars through the City to be reimbursed at the appropriate time. I can't speak for everyone, but for me, that was acceptable on my end that they are the ones that are paying for the property to have what needs done, done and then if there is a State grant they qualify for, then so be it. And we have

to act as the pass-through, so be it. The one thing I do want guard ourselves from is that we are now finding ourselves in a position where we get a State grant and just take the money when we didn't put any money into the situation. But, that's my personal opinions. They did also ask in this letter, I believe, that we table this a little bit longer so there can be more discussion and clarity and given the additional information we received this week, I would be in agreement with that recommendation and would intend to do so. But, before I make any motion, Madam President, I would open it up for further discussion if anyone on Council would have further comments.

COUNCIL PRESIDENT ISTNICK – Councilman Gregg.

<u>COUNCILMAN GREGG</u> – Thank you, Madam President. My comment on this is that the funding is there, we've been discussing a great deal a lot of if's, and's or but's. I think we need to move forward with this and get it done. We've got a property sitting there that's condemned. It's a safety hazard to citizens and our safety forces and I think it's just a matter of let's move it forward and get it done. Thank you.

COUNCIL PRESIDENT ISTNICK – Anyone else? Councilwoman Creamer.

<u>COUNCILWOMAN CREAMER</u> – Thank you, Madam President. I would agree with Mr. Lewis. We did receive a letter tonight and I really haven't had time to read through the letter. So, I would recommend also to tabeling this so it would give us additional time to review all of the needed facts and make a decision at the next meeting. Thank you.

COUNCIL PRESIDENT ISTNICK – Councilman Violand.

<u>COUNCILMAN VIOLAND</u> – Thank you, Madam President. I don't know if Mr. Maley could speak to this? I'm in favor also of possibly pushing this back a slight bit. I know we have like a May 1st deadline to get reimbursed. If Mr. Maley could comment, or if you know, Ed, about where that would put us with regard to the demo being done and completed and us submitting that to the State for reimbursement by that date.

COUNCIL PRESIDENT ISTNICK – Councilman Lewis.

<u>COUNCILMAN LEWIS</u> – In speaking with Mr. Maley prior to the meeting, he did state that this is time-sensitive for the very reason that you brought up, Mr. Violand, but he also stated that one more meeting, we could probably still squeeze in. But, deadlines are getting tight.

COUNCILMAN VIOLAND – Okay.

<u>DAVE MALEY</u> – Mr. Lewis, we are off next week too. So, it's going to push it out probably three weeks which creates a little more issue. We are starting the remediation process, I believe, is February 1st. So, that should take a few days. We'd like to get in there. The other question I have is once we got the bids in, we only have sixty days to sign a contract. I'd have to look at that as far as when we got those bids in. The other thing, to your point, was I was wondering if...I think the debate kind of surrounds whether we should move forward and whether there's an assessment put on the property or no assessment. Let me throw this out, I was just thinking about this. What if we move forward and passed it tonight, because we don't, like you said earlier Mr. Lewis, we don't necessarily have to say we're going to put an assessment on tonight. We could pass it tonight, have the money available and then put

forward legislation for next time or at some point in time, once the demolition takes place to put an assessment on. We could put an assessment on it later, if that's the process this Council wants to take, if that makes sense.

COUNCIL PRESIDENT ISTNICK – Councilman Lewis.

<u>COUNCILMAN LEWIS</u> – I would say maybe the better bet would be to meet you in the middle and call for a Special Meeting on the 30th at 6:30 p.m., specifically for this. That way we staved off that additional week. Then we can have the entire discussion; a whole meeting that is just this piece and we can then come to resolution at that time.

DAVE MALEY – That's fine, Mr. Lewis. Just to go, I mean, we received a letter from Mr. Rubin this morning and a couple of the things in the letter that I just want to make clear, or corrections, I should say. There were more than three sub-recipients to the grant. There was actually five for Stark County. We were one of the three that got 100% reimbursement. The other two were 75%. The other thing that they talked about, there being a lot of confusion. I don't know if there's confusion, I think it's just a determination of where this Council wants to go. The Law Director has made it clear that he feels confident that we can assess the property if you want to do the assessment. I know there's been some questions there. The letter also states that they have said from the very beginning that they were willing to fund this. That's not the case. As I said before, I would never probably have come to Council. They said they only had \$50,000.00 to put forward to this and that was their statement up until last week when I had an opportunity to talk to his son after our meeting last week. He called me about the meeting and said at that point, they were willing to put up half of the money for reimbursement and now this letter says the full amount. So, I just want to make clear to Council that it wasn't on our end that this was not always the case where they were willing to put the funding up. Just so that's clarification to that. And then the other thing in the letter I think misrepresents is the fact that it says that they applied for the grant. They did not apply for the grant. The City's the only one that could apply for the grant. We applied for the grant and were given the grant, not the property owners.

<u>COUNCILMAN LEWIS</u> – Mr. Maley, when you applied for the grant, you sited their specific building or property as the cause for the grant and that was what was awarded to us?

DAVE MALEY – Correct. Yes. We had to have their permission to move forward, but, that wasn't the case where they applied for the grant. A couple of other things; I brought this to your attention and I think it's important and I don't want Council to be misinformed about it. We had a situation that the City Building Dept. and Code Enforcement is looking at right now. We had an issue with two of our buildings downtown. The old Bonnie's Engraver's building, the Council President is shaking her head. Actually, it's the old Bonnie's Engraver's building which is on the corner and then the two properties to the east; the two buildings to the east. The two buildings to the east are more relevant in this matter, but, Friday we were informed and our departments went out and looked at it. The back end of those buildings blew out, in essence, and there's big holes in the backs of those buildings. We had some structural people look at it; trying to get reports, but most likely, it's going to be a major repair or a demolition on those properties. So, I just want to make sure that Council's aware of that, moving forward. Because I know a lot of the discussion has been with regards with what if something else would happen. Those buildings are owned by Mr. Kowell (Fuzzy) and really at this point, the Building Superintendent, Frank Silla, told me that those three buildings and the one on the east on the north side of Erie which used to be Tremont Coffee, he said those would be

uninhabitable as we speak today for the near future until we can figure out what's going on with those buildings.

<u>COUNCIL PRESIDENT ISTNICK</u> – So, in lieu of that, I've seen pictures of the buildings and there's just bricks hanging, is this structure, Howard's, is it good enough that it's not going to just start collapsing?

<u>DAVE MALEY</u> – That's the whole point of trying to get the buildings down as soon as possible, yes. We'd like to move forward as quickly as possible. And then the other factor that took place this week was the fact, and I think you all received a letter from Altman with regards to an offer to purchase the property. So those are all the things.

COUNCIL PRESIDENT ISTNICK – I didn't hear the last part.

<u>DAVE MALEY</u> – That the Altman Co. had sent a letter to Council with regards to their interest in purchasing the Tiger Rag's property.

COUNCILMAN LEWIS – And to be clear, that's Altman, not Aultman.

DAVE MALEY – Not Aultman, no.

COUNCIL PRESIDENT ISTNICK – Councilman Lewis.

COUNCILMAN LEWIS – Thank you, Mr. Maley. So I think the points that Mr. Maley brings up are exactly the elements that members of this Council were concerned about, and that is that we treat every property in downtown the same. And that is with the development of other properties that are finding themselves in disrepair. That property owner is also going to be responsible for whatever steps are needed to take place to remedy this and that's been my position this whole time. The State grant is great, like I've stated. I have no issue whatsoever with them holding the State grant down and just acting, the City acting as a pass-through. But, they do have to hold the responsibility of the fiscal initial investment to make that happen and they can be reimbursed. That's been my opinion. Just the same way that these other properties would be able to apply for a State grant, if they so choose. They handle it and can use us as a pass-through. With that said, I think we would be in agreement to table this. I think there's a lot of conversation. Mr. Maley, we probably will have some questions that we will need answered. Such as, will this still have to go through the bid process, I'm assuming it will because it's still involving the City. So, we're going to want some information on that. I'm also thinking that there could potentially be some amending or adjustments made to the way the ordinance is currently written and with that in mind, I am considering, and please give me feedback, having a Special Meeting called for 7:00 p.m., allowing us to start our Work Session at 6:30 p.m., starting in Finance to discuss this openly and then if we have to make an adjustment, we can. Otherwise, we've have to into a recess, make the adjustment, come back. By not starting the Special Meeting until 7:00 p.m., we can have all of our discussion and debate and if we do have to make an adjustment, we can do so and then start at 7:00 p.m. with the Special Meeting. Does that make sense to everyone? And everyone's okay with that?

DAVE MALEY – Mr. Lewis, we don't have to bid.

COUNCILMAN LEWIS – Oh, it's already been done?

DAVE MALEY – Yes. The bid's done. We already got the bids in.

COUNCILMAN LEWIS – Perfect.

COUNCIL PRESIDENT ISTNICK – Okay, Mr. Lewis.

<u>COUNCILMAN LEWIS</u> – Alright. With that said, I would like to make a motion that we table Ord. No. 184 – 2022 until January 30, 2023, at which time we will have a Special Meeting for 7:00 p.m. for this specific ordinance.

<u>COUNCIL PRESIDENT ISTNICK</u> – Okay. We'll have the Public Hearing at 5:30 p.m., start the Work Session at 6:30 p.m. and the Special Meeting at 7:00 p.m. Councilman Lombardi seconded it. Roll call.

GEORGE GLIBA - 222 Lake Ave. N.E., Massillon, Ohio. I'm a taxpayer. About a month ago I had spoke about the potholes in the parking lots. I was able to talk to a couple of the members after the meeting and I got a lot of pushback. It's like, nothing we can do. It's like, what do you mean? You can't pick up a phone and call somebody that owns the property? You guys run for these seats and you want to do what's best in the interest of the City. You might make promises to your wards and say "I can do a better job than the person that's been in here before" and quite frankly, there's seven new people and there's only two, since I've been coming up here, there's only two left and that's Lewis and Creamer. Gregg's been here awhile, too. But for the most part, all new seats. I don't really get that when property owners have a City Ordinance that they can't have a couch on their front porch, they'll get fined or the department will come after them to fine them. Why can't business owners have the same treatment? They should be held at a higher level, actually. Because they want our business, but they don't want to take care of their parking lots? Especially MP3 on the corner of Vogel and Amherst. That parking lot is a disaster. Then you go over to Meldrum's, that parking lot's a disaster. So, I feel like the Council should try to bring up an ordinance or legislation on something that there's some type of accountability because if the Law Director needs to get involved...that's something that I don't know. How is it even brought up to discussion because I've been coming up here for a while and they wanted to have a name for downtown after LaFlavour, it got on here and everybody was like...that was the craziest thing I ever heard of. To name a street after LaFlavour because they've been together for fifty years and they patronize our City with their music. So, I'd like for somebody to at least try to get some type of legislation drawn up to where these potholes are fixed in these parking lots. So, I've talked to Jill and she said "Maybe you could work out an agreement with the City to maybe call the owners and say the City will do it and you reimburse us". That was a good idea I thought. But, I've never got any type of answer back and I'm kind of wondering why nobody's really

answered me back and why it's got to be like that. And then, that's what I don't understand. If the Law Director needs to get involved; they need to get involved. Then the other thing was about one session a month to have an open forum. I talked to Lewis about it and he said when Paul Manson was here, we had an open forum once a month. And he told me it was illegal. I wrote this stuff down. So, I don't know how that's illegal and if you want people to come up here and express their opinion...I don't understand what this body would be afraid of to ask questions and give answers back, because, quite frankly, you get kind of detoured of why even come up here if nobody's going to give an answer back. That kind of holds this body accountable to ask someone a question and get an answer. That would maybe bring some people up here to speak. I'm doing this for the City. I live in this City and parts of it is getting run down and parking lots are a problem and if you don't think they are, drive through a couple of them. I think if you're honest with yourself, you would say I was right. Thanks.
