# 5. REMARKS OF DELEGATIONS AND CITIZENS TO MATTERS ON THE AGENDA

<u>ROBERT JONES</u> – I live at 7808 Cambridge N.W., Massillon, Ohio. My concerns deal with Ord. No. 6-2019, about the Aultman deal concerning the elimination of Massillon Community Hospital or Affinity and I believe or let me ask the Council members. Did you go out and talk to your constituents in the Wards? Did you knock on doors and talk to at least 50 to 100 of them

and find out their opinion? Not having them call you because some of those constituents do not know who their Ward person is. And if you did not, I feel sorry because I have a feeling that this deal is going to nip you all in the bud. My concern last week was if a person has an emergency and they end up going to Aultman West and they end up having to be admitted to the hospital, what guarantee is it that when they leave Aultman West that they are going to have a room when they get over to the main hospital? And I think that is going be a problem. And also, Mr. Roth had mentioned that the heating system and HVAC system at the hospital was checked by some people that he had and didn't come to specifications or up to snuff. But, if I was a business man and I was looking at developing something, I could have my contractor say whatever I wanted him to say and I believe that that system in the hospital is far more superior than what was stated. I also think that with the elimination of the emergency room which they don't want competition. Did you Council members and talk to senior citizens? They are the ones that are going to be suffering. If you didn't, I mean, I don't know what reading it is, second reading, you better start pondering it in your heart, what the citizens of Massillon want instead of what you as a Council person wants. The elimination of the emergency room, that's a farce because I think Aultman West would have developed out there what they wanted anyway, but they just do not want the competition and that emergency room at Affinity was state-of-the-art, it was just within the last several years. And if you let it go for a couple years, it's going to be downgraded, of course, and I'm sorry, I think all of you are going to be making the wrong mistake. All I can say is that I hope you ponder it in your heart.

**BARB SYLVESTER** – Good evening. Lori was here last week. She actually this week now is in Columbus for their quarterly meeting, so that's why she wasn't able to be here this evening. So, what this is is that every five-years, HUD requires any grantees to have a five-year

consolidated plan which is very in depth and with all of the consortiums that we work with, Stark County, Alliance, the City of Canton, they all use a consultant to assist them putting it together because of the demands of it. So, Lori went out, she did have three different bids for it and went by the recommendations, again, of the other cities and who they use and also, HUD does allow for the HUD dollars, the grant money to pay for this service and Lori did have carryover in her Services/Contracts. So, that's where the funding will be coming from. It won't be from the new action plan year. And Lori did say last evening that it's included in the quote and it's listed there if you read through it. I did agree to come in and make the presentation to Council as well, of the consolidated, 5-year consolidated once they have it completed.

# ORDINANCE NO. 2 – 2019 BY: COMMUNITY DEVELOPMENT COMMITTEE

AN ORDINANCE amending Section 1151.02 of the Massillon Code of 1985 rezoning a certain tract of land from R-3 One-Family Residential to PUD Planned Unit Development, and declaring an emergency.

**COUNCIL PRESIDENT ISTNICK** – Councilwoman Cunningham.

<u>COUNCILWOMAN CUNNINGHAM</u> – Thank you, Madam President. Due to the fact that there is going to be a Public Hearing on this ordinance, I'm giving it second reading this evening.

<u>COUNCIL PRESIDENT ISTNICK</u> – Thank you, Councilwoman Cunningham. Ord. No. 2 – 2019 has received second reading.

#### 16. NEW AND MISCELLANEOUS BUSINESS

<u>COUNCIL PRESIDENT ISTNICK</u> – Does anybody have anything? I'm going to call Mr. Smith forward to get a briefing on what's happening in Massillon.

**JOEL SMITH** – I thought Steve (Grazier) kept us up-to-date on what's going on.

**COUNCIL PRESIDENT ISTNICK** – Now you know I love hearing from you, Mr. Smith.

**JOEL SMITH** – Okay. Well, what would you like to hear about, Madam President?

<u>COUNCIL PRESIDENT ISTNICK</u> – I'd like to hear about the Fire Dept. I'd like to hear about the Rezzy. I'd like to hear about the streets, although I thought that the City did a very nice job on them this weekend.

**JOEL SMITH** – I would agree. The Street Dept. came out, I want to say about 10:00 a.m. on Saturday to begin their operations. They had their whole crew which is 11 members that worked 12 hours on Saturday until, well, some of them I think worked maybe 14 hours. That crew went home. Our Safety Dept. and a few others came out and plowed overnight for 8 hours and then the Street Dept. came back out on Sunday. Were out again for about 12 to 14 hours. They were out yesterday. I've heard a lot of good compliments about their efforts. Many people told me that our roads were better than the surrounding areas. Still work to be done. You know, they're not perfect yet. A lot of snow out there. But, when they got calls from residents on certain streets, they responded to those calls. I think the Mayor and I got a couple of e-mails over the weekend and we relayed those immediately to the Street Dept. So, I think they were responsive and did a good job. A lot of overtime worked over the holiday weekend, but necessary work for them. So, overall, we feel like they did a good job. We did put out the parking ban in hopes of getting as many vehicles moved off the roadways because we knew the storm was predicted to be very heavy. I think, overall, Lee told me that most of our residents did comply with that ban. I don't believe that the Police Dept. towed or ticketed any vehicles that weren't moved. Certainly, there was some residents with concerned that did not have driveways, but the point was get as many of them off the road as we could so we could clear the roads. So, it was better than normal for the clearing. Fire Dept., we're on course. We were predicting substantial completion by February 15<sup>th</sup>. When I say substantial completion, that would be the construction piece of it. Certainly, there'd be a punch list that we would have to go through to make sure everything was done. I'm sure the yard work will have to wait until spring. We do have in the budget to hire three new firemen by April 1st and we would hope to have the station by April 1st. That's the goal and we think we will reach that goal. The equipment for it has been bought. Some equipment like furnishings and things we're repurposing from the hospital that the Chief has found that he's able to use including lockers, office furniture, a few mattresses, bedding. There's a washer and dryer in the hospital that he's going to be able to utilize for their uniforms. So, we think it'll be open by April 1st, that's the goal. The reservoir, I think I would leave that to the Park and Rec. Dept. to determine what their plans is there. I think you've heard Steve here a couple of times say that he's going to start doing some work in the basin this spring or when the ground hardens up. You know the Park and Rec., that is a park and we'll let them lead that effort. So, specifically, you need to bring Steve in here. We're in the hiring process still with the Police Dept. We have two new hires that will be starting on February 4th. We have a third that's slated to start on April 22<sup>nd</sup> or some time in April. The Police Dept. is limited on how many they can train at a time and we're still doing interviews. Currently, we have four positions open. Two will be filled February 4<sup>th</sup> and the third one in April and hopefully the fourth on in April, we hope. The hospital situation, if you looked at our budget you would have seen that we did not put a lot of money into that account. The money is running out quickly that was in the account. I will be in front of you next week with legislation requesting additional funds for the hospital. We are looking at ways to cut expenses there. We shut off the utilities for the little medical arts building that is unoccupied. Most of the utilities on one of the Lincoln Way properties that's unoccupied are off. We have to maintain the utilities in the Amherst building. There's still one

doctor's group in that building. They have a lease still. There are two groups in the Marion building. So, the Marion building is being maintained. The hospital is down to one of the four boilers working. We have to keep the electric on. We have that MRI machine in there; you can't just turn that off. So, until a determination is made on removing that equipment, we have to keep the lights working. So, we still have the two employees there. You will see legislation coming before you next week about Wastewater wants to add two employees and we're hopeful that one of the employees at the hospital will interview and take that position. So, we'll cut back one employee at the hospital by doing that. That's where we are. You know the costs are still significant there. But we're cutting where we can. So, when we get the lease out of our hands that's the big lease on Dressler. That's a big savings and we'll continue to work to cut costs as we go along here. But, when this deal is done, you don't turn the lights off and walk away. We can't get rid of security yet as long as you have all that equipment inside. We don't want that building to start being vandalized or burgulared and we need that one employee there to continue to help with the operations of it. It's a significant operation just to keep it going. What else? Anything else?

**COUNCIL PRESIDENT ISTNICK** – Councilman Chovan.

**<u>COUNCILMAN CHOVAN</u>** – Mr. Smith, do we have any plans to order an additional ambulance for the City?

<u>JOEL SMITH</u> – I think Fire Chief is planning to purchase one later this year. They have, well, they're operating with four and they're going to purchase one later this year. His fund in that account, the 1401 account, is built to the point where we will be able afford another one. But we'll have the four ambulances. That's what we're operating with now. We'll be replacing the oldest one. I think he may keep it on hand for now, but four is really all we can operate at this point with our manpower, even with the four stations. You're only going to have 12 people working and they run with three men crews.

<u>COUNCILMAN CHOVAN</u> – Will we have, we have an assistant chief on each shift. Is he counted in that 12?

<u>JOEL SMITH</u> – No. It would be 13 with him, but the plan is, obviously, we want to watch that budget and we're going to keep four squads running at most times. The Chief and I have talked about operations, though. Especially on the midnight shift when it gets quiet. If he doesn't have a full crew, how much overtime is he going to throw out there? So, we're going to try and manage that overtime a little bit when we get to that point.

**COUNCILMAN CHOVAN** – So basically, when Station No. 3 opens, we're going to move one of the four into there?

**JOEL SMITH** – That's correct.

**COUNCILMAN CHOVAN** – So, it not going to give us anymore capacity.

**JOEL SMITH** – No.

**COUNCILMAN CHOVAN** – It's just going to give us better coverage, geographically?

<u>JOEL SMITH</u> – Right. Better geographic coverage is going to change his response zones away from what they are currently and I think there would be a better response to the northeast side with that stations there, obviously. That's what the public had asked for and we hope we're opening that station for that purpose; to make that northeast side a little better covered. But, we'll manage, again, the overtime on the midnight shift based on call volume, call histories and if we have a full crew, great. But we'll look at that overtime and rather than pay 24 hours of overtime, we may cut it back a little bit, especially late at night when the volumes are much less, we may not need the four.

**COUNCILMAN CHOVAN** – And the assistant chiefs are all qualified EMT's too, so, if they got to jump in there.

**JOEL SMITH** – That's correct.

**COUNCILMAN CHOVAN** – Okay, thanks.
