COUNCIL PRESIDENT SLATER – Thank you, Madam Clerk. Councilman Gregg.

COUNCILMAN GREGG – Thank you, President Slater. Regarding Res. No. 25 – 2026. I just wanted to mention that I was on Council with Mike. Mike served his constituents extremely well. Was passionate about Council and about his role in Council and I think that this is a fitting tribute to Mike. With that being said, I'd like to make a motion that we waive the rules requiring three readings and Res. No. 25 – 2026 forward for a vote.

Cory M. Endlich Parkway” and requesting State legislation in the naming of a portion of “Lincoln Way West” as “Sgt. Cory M. Endlich Corridor” for Sgt. Endlich giving the ultimate sacrifice while serving during Operation Iraqi Freedom; and, Whereas, Mr. Snee during his terms of office as a Member of City Council, has given outstanding service to the citizens of the betterment of Massillon; and, Whereas, the City Council desires to recognize and not upon

its official records its appreciation and commendation to Mr. Mike Snee for the excellent service he has rendered to the people and the City of Massillon during his terms of office”.

AN ORDINANCE amending PART ELEVEN "PLANNING AND ZONING CODE", TITLE THREE, "ZONING ADMINISTRATION, Chapter 1121 "Construction of Language; Definitions", Section 1121.02 "Definitions", TITLE FIVE, "ZONING DISTRICTS", Chapter 1171 "I-2 General Industrial District", Section 1171.04 "Principal Uses Permitted Subject to Special Conditions", and TITLE SEVEN "ZONING REGULATIONS", Chapter 1187 "Supplemental Zoning Regulations", Section 1187.09 "Site Plan Review" of the Codified Ordinances of the City of Massillon, Ohio.

COUNCILWOMAN HARWIG SMITH – Thank you, President Slater. This is our data center legislation. This will be the second reading. We amended this legislation so now that data centers will only be allowed in General Industrial Districts, I-2, which is full industrial and the Site Planning Commission will be responsible for reviewing the electricity needs, how much water, the sewage and everything. Did anyone have any comments at this time? Okay, second reading.

ORDINANCE NO. 67 – 2026

BY: PUBLIC UTILITIES & ENVIRONMENTAL COMMITTEE

AN ORDINANCE to provide for water service to be furnished by Aqua Ohio, Inc. to the City of Massillon, Ohio, and the inhabitants thereof, and to regulate the rates under which water service shall be furnished in the City of Massillon, Ohio, for and during the period from January 1, 2027 through December 31, 2031.
