**L.J. DELUCA** – Thank you, Madam President. I want to thank you, personally, Madam President for without a doubt, without even thinking about it, for approving the projector so that the residents can put their smartphones in. I have even something tonight, which I couldn't do, but I know we have time to tape that. I went through the lights in downtown Massillon; they all turned green all at once. Even though we had some of the City of Massillon people say that they want to stagger those lights; they're not staggered at all. It's like Indy 500. So, Larry L.J. me, I'm reaching out to you. I want to talk about Chipotle today. I called them last week, I thought the problem was cleared up, but it isn't. Evidently we have a problem, Massillon. You go to Chipotle and I like Chipotle, I haven't been there recently, but I'm going to be going there and I'm going to check up on this. I understand they have a money problem. They say they're not giving back the change. For instance, they're saying the Bank of America. I did call Chris, who's the general manager there, last week and I called the manager tonight and I said that you have those signs up there that Chris told me that are going to be up there that you got to have exact change. Why in the world that is? I don't know. This is not the way to do business in Massillon, Ohio. It's not the way to do it at all, period. So, you give the people their change in Massillon, Ohio, and if you aren't going to give it to them, put the sign up all the time. I'm going down there after tonight's meeting and I'm going to check it out again. I just got off the phone with a lady, the manager and was in a daze. Almost twenty years since 9/11, almost twenty years, I just can't get over it. I'm very sad about it. Debbie Lindsey, vice-president of Mancan which is a Massillon based business, says she hasn't seen it like this for the labor market. Over the next year, the job market is going to be very, very tight. It's going to be tight right now as a matter of fact. I know Mr. DiPetro, Skyland Pines is having a million square feet. They won't tell us what's going in there. My guess it's Amazon. Who builds a one - million-dollar square foot warehouse at Skyland Pines. When we already have three or four that I visited in North Randall, Euclid or wherever it is. So, I do think it's not a big secret there, Stark County. So, it's going to get tighter. Our employment picture is going to get tighter, the employers are going to have a harder time like Debbie Lindsey said. Restaurant owner's I just feel, changing the subject here, are being punched, kicked, scratched just like UFC fighters. COVID-19, the coronavirus, the delta variant right now is proving even more fatal. It's going for the young, it's going for the unvaccinated, it is going for the vaccinated, but they're not having as bad of symptoms. I've talked to a few doctors here in town and it's like a water spring; out of control. We had a camp in the mountains of Pennsylvania, it's spewing that water out all over, okay. And Massillon, I think we got to take it very serious, we can't take this slightly. Want to mention Smiley's restaurant to bring out the best in the best it can be embracing the concept of family considering the customers as well as the staff he creates at his restaurant. He wanted to put this in place so everybody feels normal even though you got the PPE equipment. So, he put in these, this is the second thing, on every table, on every table. I know some restaurants I go into, because I eat out every day, they have one thing. Some don't have any at all. That shows you that they may not care as much. So, kudos out to Smiley because I've known him for forty-nine years. I started out being a dishwasher with him when I was sixteen; I've known him for forty-nine years, we did a lot of business and stuff there and believe me, he's very innovative and he's on top of it.

**COUNCIL PRESIDENT ISTNICK** – One minute.

**L.J. DELUCA** – Thank you, Madam President. I was sixteen back then, didn't have a worry in the world. We were playing, when I was working there at Doubletyme with Mickie and Smiley, there was this song "Don't Worry, Be Happy", Bobby McFerrin, I think it was. I think he's died since then; me and Smiley always go over that. That was in 1988. All activity, foresight, expanding, planning, fundamentally changing direction of businesses. COVID-19, some businesses didn't take it head on, Madam President. They went around it. They got creative. We got to remember Uber, that was in 2008 – 2009. That's what forced companies to be creative. And I want to say not only Smiley's, but Norca that I went to up in Cleveland, it's a Spanish-Portuguese restaurant, they even have a special menu for the people and they said we'll deliver to you and by gosh, they had forty-five orders in fifteen minutes. So, I know a lot of restaurant owners, I know a lot of owners, period, that are having a rough with this, but, I

just want to make sure that we're not taking this lightly. We have to take this seriously. So, thank you, Madam President, thank everybody and I want to thank all of the listeners for getting back with me. It does make a difference. Thank you, Madam President.
