<u>COUNCIL PRESIDENT SLATER</u> – Good evening. Welcome to the Massillon City Council meeting for Monday, November 17, 2025. We have in attendance the following City officials: Mayor, Jamie Slutz, Safety Service Director, Renee Baker, Chief Counsel, Earle Wise, City Engineer, Alex Pitts, Director of Development, Ted Herncane and Income Tax/Budget Director, Lori Kotagides-Boron. Under #5 on the agenda is where the public can speak on any topic that appears on tonight's agenda and under #17 is where the public can speak on any topic that does NOT appear on tonight's agenda. I'd like to remind you that if you have a cell phone, please set it to mute, vibrate or turn it off. Thank you.

COUNCIL PRESIDENT SLATER – Thank you, Councilwoman Cunningham.

4. READING OF THE JOURNAL

<u>COUNCIL PRESIDENT SLATER</u> – Madam Clerk, are the minutes of the previous meeting transcribed and open for public viewing?

COUNCIL CLERK ROLLAND – Yes, they are.

COUNCIL PRESIDENT SLATER – Are there any additions or corrections to be made?

COUNCIL CLERK ROLLAND – No, there are not.

<u>COUNCIL PRESIDENT SLATER</u> – If not, then the minutes stand approved as written. Thank you, Madam Clerk.

COUNCIL CLERK ROLLAND – You are welcome.

5. REMARKS OF DELEGATIONS AND CITIZENS TO MATTERS ON THE AGENDA

CODA GALLAGHER – I live in Ward 5 and I'm here to talk about Ord. No. 98. I spoke two weeks ago about it. It's the camping ban. My thoughts were kind of unorganized two weeks ago, so, hopefully this is more sensible. So let's break down exactly how this piece of legislation could play out. So, say we have a homeless person who is simply down on their luck and struggling and take any help that they are offered. The only thing that this ordinance guarantees is that the City will notify local social services before forcing them to move within twenty-four hours without a guarantee that the individual will be offer any assistance. Now even if this individual takes help that they may be offered, homeless shelters are often full, dangerous and understaffed and when homeless people are already a vulnerable population. it's very likely that they could end up back on the streets. I've seen both members of the Council and the Administration bring up homeless campers who do not accept help as if it's a decision that any person wants to make. But a person who chooses to live on the streets does not do so because of laziness or lack of ambition but because their society has failed to show them that they can demand better. They've been through the system and they've seen how broken it is and if the system worked, we wouldn't be having this conversation at all. And rather than attempt to fix that system, we're here trying to tell people that they're criminals for not participating in it. The Administration claims that this charge is only a minor misdemeanor and carries no jail time which is true. But what happens when you repeatedly move people who are camping and force them to do community service? How many time does that need to happen for an individual to start looking for private property to sleep on and what happens if they don't show up for that community service? Both of those situations could lead to jail time. You can't create conditions that push people to commit a crime and then call it justice when you charge them for those crimes. The Administration assures us that they doubt that any homeless person would be charged with the \$50.00 fine. But then, why include the risk of the \$50.00 fine in the first place when anyone charged with a crime likely cannot afford it? Mayor Slutz and members of the Council have promised that they do want to help homeless people and that this ordinance does not put homeless people at risk. And promises are great, but our judicial system functions using laws and not promises. Last week when I asked if anyone from the previous meeting had talked to Mayor Slutz afterwards, he said "No". Which I think is very telling how disconnected this ordinance is from the needs of homeless people. I'd like to ask the Administration, "How many homeless people did you talk to about this ordinance before drafting it up?". Last week, several members of the Council expressed their annoyance of the public response to this ordinance, but I'd have to say that the biggest effect that this ordinance has on you is that you have to read mean Facebook comments. Meanwhile, homeless people have repeatedly told you how it threatens their livelihoods and puts them at risk then you have no reason to complain about the backlash. I think that the solution is controversiously clear. Creating an actual comprehensive plan for addressing homelessness in the City and assign designated spots for people to camp. Provide restrooms, trashcans, running water and hygiene products. No one is here to say that the Council or the Administration wants to hurt homeless people and I sympathize with the desire to mitigate cases of public camping, but camping bans have only ever done harm to homeless people and we all have a responsibility to fairly judge these ordinances. Thank you.

COUNCIL PRESIDENT SLATER – Thank you.

<u>GAGE BARRETT</u> – I live in Ward 1. I'll be discussing the same ordinance as him when it comes to the prohibited camping ordinance. There seems to be a disconnect of the purpose of the ordinance concerning banning camping. The Council spoke last week and said that the purpose of this ordinance is to provide help for these homeless people. With the exact language of the ordinance, it suggests nothing of the sorts. You say you don't want to criminalize homelessness, but I don't see this going anywhere else. No homeless person can

afford a \$50.00 fine, so what comes after? Well, last week community hours were suggested to try to connect them with the community. Marcum suggested two hundred to three hundred hours. I don't see this working and it seems very excessive. Putting someone to work without pay won't get them a stable environment nor would that help people who end up in such a situation get out of it. What happens to children of people who are homeless? And furthermore, what would happen if they don't serve those community hours? Jail time? We're speaking of people who are currently homeless. Who have likely found themselves in even worse situations. Like the individuals who have found themselves with addictions and mental health disorders. The City isn't interested in people at such lows, but what does this do for people or families in the future who end up homeless simply because they can no longer afford the basic necessities. There are ways to aid people who are down on their luck and the people who can no longer afford the cost of living. Affordable housing, less big homes and more aggregation of affordable apartment complexes. More accountability for landlords and according to Coda, it was previously discussed that there is an issue with landlords who don't even live in Massillon, let alone the state. We need social workers who aid homeless folks to get out of these situations. The ordinance briefly mentioned social services, but it's ambiguous and vague. What happens if the services are unavailable? Some people may see these suggestions and say that the City can't afford it. I think not. Ord. No. 73 – 2025 was an ordinance to pay for the replacement of a golf course's equipment. If we can pay for meaningless things such as a golf course's equipment, we can afford to provide people affordable housing and care that need for their basic necessities. Thank you.

COUNCIL PRESIDENT SLATER – Thank you.

KRISTI GERBER – I live in Ward 2. I want to live in a City that is equitable, not just a City that look equitable. I listened to the recent working meeting on the proposed camping ban, which is what I'm talking about today. I heard repeatedly from the Mayor and several Council members that you want to help people and that you do not want to criminalize homelessness. I believe that intention is sincere. But intention alone isn't enough especially when the policy language does the opposite of what we say that we value. Helping people has two parts; one, offering real solutions and lowering barriers and two; not adding to the harm people already face. This ordinance, in its actual language applies a misdemeanor to those who violate it. That is criminalization. Not an unintended consequence, but the literal design. Without this ordinance, the act of sleeping in a public for survival is not a crime. With it, it becomes one. We get to decide whether that should be true. If we truly want to help our unhoused neighbors, then we have to commit to solutions that are not only on a personal level, but like we're talking about helping people on a personal level, but at a seismic level and seismically this ordinance creates harm. A misdemeanor makes housing, employment and services harder to access. It adds barriers of the very moment that we should be removing them. This ordinance could, instead, have been an opportunity. An opportunity to expand affordable housing to strengthen temporary shelter options, to approval access to care or to reduce the barriers that residents repeatedly described. It could have been aligned with established research approaches that actually help accept homelessness. At the last meeting, someone asked for the language of this ordinance came from. The fact that the source was unclear suggests that little research was done on whether camping bans are effective at helping people at all. That should concern us. So I have a couple of questions that I hope Council will seriously consider. What strategies have other cities used that are truly effective at reduce homelessness and two, what barriers exist in Massillon that keep people from accessing help? How can we remove those instead of adding fines and misdemeanors? If our goal is to help, then we must invest in the things that actually help and that means removing barriers to housing. Not creating new ones through criminal penalties. Thank you.

AN ORDINANCE authorizing the Director of Public Service and Safety of the City of Massillon, Ohio, to transfer Parcel #10003714, a 0.98-acre, vacant commercial property currently owned by the City of Massillon to the Community Improvement Corporation of Massillon (CIC) for the purpose of economic development.

<u>COUNCILWOMAN CREAMER</u> – Thank you, Mr. President. We've had multiple discussions regarding this ordinance. The purpose of this ordinance for this parcel, Mr. Ben Gulley and Mr. Dallas Young has communicated to Council on multiple occasions to construct an indoor sensory park for children with special needs. After further discussion, I would like to amend this ordinance to include under Section 2, "The instrument transferring the property from the City to the CIC shall contain a restrictive covenant restricting the use of said property to non-profit uses. Said restrictive covenant shall contain a reversionary interest held by the City of Massillon in the event the property is used for any purpose other than a non-profit purpose.

The City's reversionary interest and this restrictive covenant may be bought out for the parcel's value as assessed by the Stark County Auditor for the years of 2021, 2022 and 2023 (\$24,100.00)." So I'd like to bring this amendment of Ord. No. 88 – 2025 up for a vote.
