The City of Massillon is proposing to undertake the following housing and community development activities under the DRAFT FY 2022 Action Plan that has been developed for the FY 2022 CDBG Program Year, which will begin July 1, 2022 & run through June 30, 2023.

- 1. The provision of decent housing that is affordable to low and very low-income households.
- 2. The provisions of a suitable living environment, improving the safety and livability of neighborhoods, increasing access to quality facilities and services, improving housing opportunities, and revitalizing deteriorated neighborhoods.
- The expansion of economic opportunities, creating jobs that promote long term economic and social viability and that are accessible to low and very low-income persons.
