We are contracted with Stark County to install new septics but certifying contractors and annual inspections are our responsibility. The fees for these services should pay for the program. Bethany Perkowski will present the program and fees. On a motion by Ann Palaski, and seconded by Cyrus Ausar, it was approved to begin a septic program and the 1st reading of fees. Motion carried.

- 3. Approval of Resolution 02-2022 to begin a camp program and 1st reading of fees
 - a) The Massillon City Health Department needs a camp program to monitor carnivals and festival companies who camp in the city limits for multiple days. Bethany Perkowski will present the program and fees. On a motion by Ann Palaski, and seconded by Jeff Thornberry, it was approved to begin a camp program and the 1st reading of fees. Motion carried.
