New Business

- 1. Approval to renew Terri's REHS license for 2024 for \$78.50.
 - a) Terri stated "Registered Environmental Health Specialist, formerly Sanitarian license, will be good for 2 years."

Motion was made by Cathy Heitger to approve the renewal of Terri's REHS license For 2024 for \$78.50. Seconded by Sonia Ullum. No further discussion. Motion carried.

- **2.** Approval to close the Health Department on April 8, 2024, the day of the Solar Eclipse, for staff safety. Also, schools are closing, parents will need to be home.
 - a) Terri states "We ask the Board to pass this as most of our staff have kids that will be home that day. I feel it is important for non-essential personnel to stay at home that day with their kids...also, all the traffic that we are expecting. We are asking for closing with pay, as it is our decision to close. Essential personnel will be in the office if necessary. I will be here, in case a public health emergency arises.
 - b) Sonia Ullum asks if it is normal to close down with pay. Terri replies "Normally it is with pay if we choose to close down. If it were for a different reason such as staff wanted the day off, they would need to use their own paid time."
 - c) Cathy asks about possibly needing permits approved that day. Terri says she will be in the office and will assist where needed.

Motion was made by Sonia Ullum to approve closing the Health Department on April 8, 2024 for the Solar Eclipse. Seconded by Cathy Heitger. No further discussion. Motion carried.





- **3.** Announcement- Canton Public Health has agreed to support our HIV testing program through 2024.
 - a) Terri states "this is exciting. We have been doing really well so far. They are going to provide funds for everything all supplies, advertising etc. They're going to carry us through for another year. It was experimental, we started at the end of this year. They're pleased with our progress. So very good news."
- **4.** Announcement- We will be putting HIV testing information on 2 community billboards.
 - a) Terri states "This will be completely provided with HIV funds. We think it's a great way to get the word out. We have had messages put out on social media and ads in the newspapers, but we feel this is another great way to get the information out to the public. One of them will be right around here, and the other, I believe, will be off 21. Our name will be out there as well as where you can go for testing."
- **5.** Announcement- Good job to our Environmental Division for a perfect passing score on their annual pool/spa ODH survey!
 - a) Terri states "these surveys are very tough and they passed with a perfect score. They didn't have to do any plan of action. They did really, really well. We are very pleased and proud of them."

- 6. Terri would like to add an additional item.
 - a) We are so proud- our Health Department, through our WIC division, has been designated a gold level breast-feeding workplace by governor DeWIne. We have our own private room for nursing mothers. We have our WIC staff to thank for that!
