## Dear Applicant,

In answer to your inquiry, the City of Massillon requires all Electrical Contractors to be registered with the City of Massillon. To become registered as an Electrical Contractor, you will need:

- 1. To fill out an application. There is a \$125.00 non-refundable fee.
- 2. To submit a copy of your driver's license or state identification card
- 3. To submit a copy of your current State License.
- 4. To submit a copy of your Worker's Compensation certificate, should you have employees.
- 5. To obtain a \$10,000.00 surety bond form enclosed.
- 6. To submit the yearly registration fee of \$150.00. The registration is good through February 28<sup>th</sup> of each year. The registration belongs to the person who holds the State License and should he/she leave the company, the registration goes with him/her.
- 7. Permits are to be obtained before starting the job and it is your responsibility to call for all needed inspections.
