To All Applicants for Registered Electrical Journeyman:

It shall be your responsibility to submit to the Board the following information on or before the application cut-off date:

- 1. Proof of experience and hours showing 10,000 hours in the electrical trade (5 years of W-2 forms).
- 2. Two letters of recommendation on letter head.
- 3. Copy of your driver's license.
- 4. A completed application.
- 5. An examination testing fee of thirty-five dollars (\$35.00).
- 6. Once you have passed the test, an additional Electrical Journeyman registration fee of fifteen dollars (\$15.00) will need to be paid to receive your Electrical Journeyman Registration.

Failure to provide complete information promptly with applications shall cause applicant to be subject to denial of test.

## MASSILLON CITY ORDINANCE 1313 SUBSECTION 1313.05 QUALIFICATIONS FOR LICENSE

The applicant for an electrical contractor's or journeyman electrician's license shall be at least twenty-one years of age and a citizen of the United States. He shall meet at least one of the following tests of experience and/or education and education and experience shall be verified by presentation to the Electrical Board of appropriate diplomas and tax information.

- (a) Ten thousand hours of practical experience in the electrical trade;
- (b) Two years of electrical technical training in a school accredited by either the State of Ohio or the United States Department of Labor, Bureau of Apprenticeship and Training, plus six thousand hours of practical experience in the electrical trade;
- (c) A degree from an accredited college or university as an electrical engineer plus four thousand hours of practical experience. (Ord. 87-2001. Passed 5-7-01.)

Tests are held in Massillon City Council Chambers on the 2<sup>nd</sup> floor of the Municipal Government and Justice Center, One James Duncan Plaza, Massillon, Ohio. Should you have any questions concerning this matter, please contact our Electrical Inspector, Frank Silla, at (330) 830-1724.
