Dear Applicant:

In answer to your inquiry, the City of Massillon requires all HVAC contractors to be registered with the City of Massillon. To become registered as an HVAC Contractor, you will need:

- 1. To fill out an application. There is a \$75.00 non-refundable fee.
- 2. To submit a copy of your current State License and Driver's License.
- 3. To submit a copy of your Worker's Compensation certificate, should you have employees.
- 4. To obtain a \$10,000.00 surety bond form enclosed.
- 5. To submit a yearly registration fee of \$150.00. The registration expires on February 28th of each year. The registration belongs to the person who holds the State License and should he/she leave the company, the registration goes with him/her.
- 6. Permits are to be obtained before starting the job and it is your responsibility to call for all needed inspections.
