MONTHLY REPORT: November 2025

From: Anna Jordan-Community Development Coordinator

- **Housing:** We completed a full rehab project, and the contractor has been paid in full. We had a successful lead inspection, and completion paperwork with fund request was sent to RPC . We have another full rehab. project in the works. Appraisal was received, intent to proceed was returned, and project is being bid out to contractors. If we should receive any other homeowners that are interested, we are in a position to send another application packet. We have adequate funding for projects, but we have had trouble finding qualifying homes for this specific program. Home buyer program calls have slowed down. If we receive inquiries about this program, we continue to supply resources for down payment assistance from outside organizations. Funding for 2025 has been received per RPC.
- **Fair Housing:** For the month of November I received 18 calls . We received calls mainly regarding neglected repairs. Tenants are usually informed of the options, and if outside we can get code involved. In some situations. Inquiries continue to come in regarding housing units/shelters. Received calls from individuals looking for rental assistance, and or utility assistance. I provide information I have available to me to them. We assess calls and determine if a fair housing complaint is needed. We work as a middle person for landlord/tenant issues as needed. Some were given information regarding legal aid. We supply as many resources as possible. Zero calls I had involved fair housing.
- **Community Development :** In November We installed two furnaces for LMI families, and a third homeowner who needs a furnace completing application paperwork We currently have two window projects in progress, and two income approved homeowners we are working with on complex plumbing situations. A roof is in process of being installed for a homeowner who was experiencing leaks, and a homeowner with disability need of a modifications project has been bid to contractors. A homeowner who is need of hot water tank and a roof has submitted application paperwork, and we need work specifications. With new grant funding available, we can have more projects active at this time. Projects are set and ready to go in IDIS Projects/activities in IDIS for the 2025 program year. Sub-recipient contracts have been executed, and onsite reviews were performed as well.
- **Administrative:** Manage phone calls. IDIS activities and projects set up, funded, and updated as necessary. Prepared and paid bills/ IDIS drawdowns for funds. Ledgers balanced and maintained accurately throughout the month. Other tasks upon assignment. Supplies ordered as needed. RPC set up and completions completed in a timely manner. Prepare documents as needed for meetings. Application packets prepared and mailed. New files set up as needed. Schedule events, prepare flyers etc.

Economic Development

Fielded calls regarding new business opportunities to discuss site location, zoning, and site plan review procedures. Met with Aqua Ohio representatives on current and future development projects. Met with Massillon Development Foundation subcommittee to discuss future industrial sites for economic development. This committee will continue to work to identify new areas in Massillon for development. Held CIC meeting to transfer property to LBG Properties LLC. Met with two (2) local companies about proposed expansion projects in 2026.

Community Development

Continued CDBG administrative duties including accounting and financial management for CDBG expenditures, monitoring expenditures for all activities in IDIS, and monitoring of CDBG sub recipients and their programs. Fielded calls from residents regarding the City's vacant land reutilization program and questions regarding zoning requirements for various projects. Worked with code enforcement officers and held weekly status meetings to go over procedures, record keeping, and implementation of the International Property Maintenance Code (IPMC). Several Code cases are being reviewed by the Law Department for prosecution. For CDBG FY 2025 City of Massillon will receive \$646,321 which is a 0.992% decrease from the grant amount estimated at the time of passage by City Council. Met with representatives from the BIA of Stark & East Central Ohio to discuss opportunities for new home construction and vacant lot acquisition.

 - Home owner in need of Plumbing work is delayed, Whisler Plumbing, Beverly Lewis are scheduled to meet at the home of the homeowner to discuss what possibly can be done and estimate how much we may be able to do to rectify the plumbing situation.
 - Windows for one homeowner completed and waiting on the final from RPC.
 - We have a request for plumbing and hot water tank, request to Building Department for specifications received, Intent to Proceed sent.
 - Home owner request for a furnace, complete, Contractor paid.
 - Home owner request for windows awarded, pre-construction pending.
 - Homeowner request for a furnace approved. Pre-construction scheduled.
 - Homeowner in need of a modification, placing her washer and dryer upstairs, specification received and bids requested.
 - Home owner requesting electric & roof. Packet returned, however several things are missing, can not move forward.
 - Homeowner request for a roof, packet returned and under review, she was asked to apply in 2026, because we were unable to verify income. Her daughter was in an accident and money received was put into mom's account over the last six months, her daughter does not have a checking account.

The following are applications that have been sent out and the status of the same – Under review means we have received them and working on their qualifications- There are 4 packets received, three approved and one does not qualify.

One additional packet sent out and nothing returned.

- **Other Activities: Fair Housing** – November 4, 2025, Director's Meeting 9:30; Pre-construction for homeowner 10:00 for a furnace and a second homeowner at 11:00 for a roof; November 12, Preconstruction for homeowner 3:00 in need of windows; November 18, 2025 Continuum of Care, Google Meet, 8:30 – 10:00.

- We continue to receive, respond and refer calls on a daily basis. Major concerns have been persons seeking shelter, looking for cheaper living space and information concerning Subsidized housing and other helps. Information and referrals were sent as request came in. The Housing Department also provides a Subsidized Housing List and other helps, for individuals who may qualify. We also receive calls from Health Care Providers who care for persons who may need emergency assistance and may not know about our program. Additionally, people are calling to find out about managers in Trailer Parks who seem to have no regulations in raising rent, denying repairs and over all up keep of the trailers that are rented and grounds. Since we have no jurisdiction to assist, many are living in deplorable conditions and receiving cruel and unreasonable treatment. We can only refer them to the Manufactured Home Commission, out of Columbus, OH., who should be their resource and help. However, I have not found out what help they provide as, trailer parks continue to deteriorate.

The total income tax receipts posted for November 2025 was \$2,118,888.19. This amount is an increase from November 2024 of +19.48%.

Year to date income tax receipts posted through November 2025 was \$24,577,624.42. Receipts posted for 2025 is an increase from 2024 of +3.46%.

Payroll tax withheld by Massillon employers represents 77% of all tax collections through the year of 2025. Individual income tax payments represent 11% of all tax collections through the year of 2025 and Net Profit income tax payments represent 12%.

Average monthly income for the eleven months of 2025 is \$2,234,329.49. Average monthly income for the year of 2024 was \$2,129,262.05. Average monthly income for the year of 2023 was \$2,060,967.62.

Year to date refunds for 2025 was \$637698.62.

Target budget from Auditor's Revenue Report is 91.67% for the following accounts for 2025. Account percentages collected for the eleven months of 2025 are as follows:
